BY-LAW NO. 2004-185

BEING A BY-LAW TO AUTHORIZE THE SALE OF LANDS TO LARRY McCORMACK and SHERRY ANN ILERSICH (144 Campbell Avenue – Between Lots 99 and 100, Plan 55)

WHEREAS an Agreement of Purchase and Sale with Larry McCormack and Sherry Ann Ilersich for the sale of vacant city owned land was approved by Resolution No. 2004-734 passed on the 18th day of October, 2004, after an open, competitive process;

AND WHEREAS the Municipality is authorized by Section 268 of the *Municipal Act*, 2001, to dispose of lands no longer required for municipal purposes;

AND WHEREAS the lands herein were declared surplus by Resolution No. 2004-488 which was passed by Council at its Regular Meeting held on Tuesday, June 29, 2004;

AND WHEREAS the notice of sale of this City owned land was advertised for one week in the North Bay Nugget on September 17, 2004 and;

AND WHEREAS an appraisal of the lands was completed in September 2004;

AND WHEREAS Council deems it desirable to convey Plan 55, Between Lots 99 and 100 to Larry McCormack and Sherry Ann Ilersich.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The Corporation of the City of North Bay enter into an agreement with Larry McCormack and Sherry Ann Ilersich dated the 13th day October, 2004 relating to the sale of vacant city owned land described as Plan 55, between Lots 99 and 100, City of North Bay, District of Nipissing.
- 2. The Corporation of the City of North Bay is hereby authorized and directed to transfer Plan 55, between Lots 99 and 100, City of North Bay, District of Nipissing to Larry McCormack and Sherry Ann Ilersich.
- 3. The Mayor, and the Clerk of The Corporation of the City of North Bay are hereby authorized to execute that certain agreement between The Corporation of the City of North Bay and Larry McCormack and Sherry Ann Ilersich and to affix thereto the corporate seal, and the City Solicitor is hereby authorized to execute such further and other documents as may be reasonably required to complete the transaction.

READ A SECOND TIME IN OPEN COUNCIL THE 15TH DAY OF NOVEMBER, 2004.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 15^{TH} DAY OF NOVEMBER, 2004.
