BY-LAW NO. 1159

BEING A BY-LAW appointing a Fire Chief and several members of the Fire Department for the City of North Bay.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

- 1. That By-Law Number 1151 and all other By-Laws affecting the Fire Chief and the several members of the Fire Department be, and the same are hereby repealed except By-Law Number 1015.
- 2. That G. M. BRADY be hereby appointed Fire Chief.
- 3. That JAMES LUESBY be appointed Sub-Chief.
- 4. THAT WALTON WALLACE be appointed Captain.
- 5. That JOHN BOUCHER, P. VACHON, HERBERT JESSUP, GEORGE MCARA, WILLIAM LONG and FRED STRANGE be appointed regular Firemen.
- 6. That O. BEDARD, A. MEECHAM, W. BRADY, R. ATKINS be appointed Volunteer Firemen.
- 7. That the salaries of officers and members of the Fire Department be payable on the first and fifteenth of each month, and shall be as follows:
- (a) The Fire Chief shall be paid at the rate of \$1800.00 per annum.
- (b) The Sub-Chief shall be paid at the rate of \$1380.00 per annum.
- (c) The Captain shall be paid at the rate of \$1260.00 per annum.
- (d) That each regular fireman shall be paid at the rate of \$1200.00 per annum.
- (e) Each Volunteer Fireman shall be paid at the rate of \$180.00 per annum.
- 8. That the Fire Chief, the regulars and the volunteers shall receive their full salary on the first and fifteenth of each month.
- 9. The Fire Chief will have supervision over the staff and may discipline and suspend for cause any member of the Fire Department and report at once to His Worship the Mayor or to the Chairman of the Fire, Water and Light Committee, who must report to Council at first regular meeting.
- 10. That officers and members shall be divided into two platoons and that the hours of duty for the members of each platoon shall be determined by the Chief.
- 11. That the Chief will inspect all mercantile premises and public buildings at least every three months and encourage fire prevention throughout the City and have fire drill in all schools.
- 12. That the Fire Chief will keep an accurate record in convenient form for references of all fires occurring in the City and operations thereat.

- That the Fire Chief will hold fire drills in his Department and see that his men are proficient in handling the equipment, life saving and first aid.
- That the Fire Chief will send to the Fire, Water and Light Committee on the first of each month a written report setting out the activities of the Fire Department together with suggestions for the improvement of the service.
- 15. He will see that no fire fighting equipment is used for anything but fire fighting or drill purpose, except with permission of the Mayor or Chairman of the Fire, Water and Light Committee.
- The Fire Chief will not absent himself from duty (except his regular day off) without permission from His Worship the Mayor or the Chairman of the Fire, Water and Light Committee.
- That the following shall be the duties of the assistant chief and captain:
- (a) They shall work in harmonious conjunction with the Fire Chief and act under his instructions and report to him all breaches of discipline under their command.
- (b) In the absence of the Fire Chief the Assistant Chief or Captain shall perform all the duties, assume all the responsibilities of the Fire Chief and perform such duties as his superior may direct.
- (c) The Assistant Chief or Captain shall command at fires when he is first to arrive and exercise command until the arrival of the Fire Chief.
- (d) The said Fire, Water and Light Committee shall have power to make such rules and regulations as they may consider necessary for the discipline, care and protection of the Department subject to the approval of the Council.
