

**The Corporation of the City of North Bay**

**By-Law No. 2018-27**

**Being a By-law to Amend the City of North Bay Accessible Parking  
By-law No. 2007-89**

**Whereas** section 9 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under that Act or any other Act;

**And whereas** section 10(1) of the *Municipal Act, 2001* provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

**And whereas** section 10(2) of the *Municipal Act, 2001* provides that a single-tier municipality may pass by-laws respecting the following matters: subparagraph 5, economic, social and environmental well-being of the municipality, including respecting climate change; subparagraph 6, health, safety and well-being of persons; subparagraph 7, services and things that the municipality is authorized to provide under section 10(1); subparagraph 8, protection of persons and property including consumer protection; and subparagraph 10, structures, including fences and signs;

**And whereas** Council may authorize the creation and designation of parking spaces on highways and/or municipal or private property for the exclusive use of vehicles which are displaying a valid Accessible Parking Permit in accordance with the requirements of the *Highway Traffic Act, RSO 1990* and the regulations made thereunder, the *Municipal Act, 2001* and the regulations made thereunder and the *Accessibility for Ontarians with Disabilities Act, 2005*, and regulations made thereunder and this by-law;

**And whereas** Resolution No. 2018-66 was passed by Council at its Regular Meeting held on Tuesday March 13th, 2018 to authorize amendments to the Accessible Parking By-law No. 2007-89;

**Now therefore the Council of The Corporation of the City of North Bay hereby enacts as follows:**

1. That Schedule B to the Accessible Parking By-law No. 2007-89 be hereby amended by removing the following:

<b><u>ROAD</u></b>	<b><u>SIDE</u></b>	<b><u>FROM</u></b>	<b><u>TO</u></b>
First Avenue	East	A point 64 metres east of Fraser Street	A point 70 metres east of Fraser Street

2. That Schedule B to the Accessible Parking By-law No. 2007-89 be hereby amended by adding the following:

<b><u>ROAD</u></b>	<b><u>SIDE</u></b>	<b><u>FROM</u></b>	<b><u>TO</u></b>
First Avenue West	North	A point 64 metres east of Fraser Street	A point 70 metres east of Fraser Street

3. That this By-law comes into effect upon being passed.
