

BY-LAW NO.1763

BEING A BY-Law of the Municipal Corporation of the City of North Bay to close certain streets and lanes, said streets and lanes being part of Wellington Street, part of Bank Street, part of Sparks Street, and part of Rose Avenue and part of the lanes as shown on Plan M-163 filed in the Office of Land Titles at North Bay, Ontario.

WHEREAS the Municipal Council of the Corporation of the City of North Bay have been requested, and upon consideration deem it advisable to close certain streets and lanes in the City of North Bay, said Streets and lanes being composed of part of Wellington Street, part of Bank Street, part of Sparks Street and part of Rose Avenue and part of the lanes as shown on Plan M-163 filed in the office of Land Titles at North Bay, Ontario,

THEREFORE under and by virtue of the authority vested in the Council of the Municipal Corporation of the City of North Bay by the Municipal Act, being R.S.O.1950, Chapter 243, THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT part of Wellington Street, part of Bank Street, part of Sparks Street and part of Rose Avenue and part of the Lanes as shown on Plan M.-163 filed in the Office of Land Titles at North Bay, Ontario, more particularly described as follows.

Taking the bearing South 89°0' East of Lorne Avenue as governing bearing herein: COMMENCING at the north-westerly angle of the said lot 419; THENCE south 89°0' East along the southerly limit of Lorne Avenue a distance of 923'11" more or less to the north-easterly angle of the said lot 149; THENCE South 0°08' East along the westerly limit of the lane shown on the said Plan M-163 a distance of 945'6" more or less to the south-easterly angle of the said lot 124; THENCE North 89°0' West a distance of 443'1" more or less to the south-easterly angle of lot 287 shown on the said Plan M-163; THENCE North 0°10' East along the Westerly limit of Bank Street a distance of 231'0" more or less to the south-easterly angle of the said lot 280; THENCE North 89°0' West a distance of 486'0" more or less to the south-westerly angle of the said Lot 401; THENCE North 0°10' East along the easterly limit of Brennan Street a distance of 714'6" more or less to the point of commencement, ARE HEREBY CLOSED AND STOPPED UP.

2. THAT forthwith upon this By-Law taking effect the Council of the Municipal Corporation of the City of North Bay shall convey the said streets and lanes as closed and stopped up in the next preceding section to the registered owners of the lands abutting thereon for the consideration of the sum of ONE DOLLAR (\$1.00).
3. THAT the Council of the Municipal Corporation in the City of North Bay shall hear in person or by his or her solicitor, counsel, or agent, any person who claims that his or her lands will be prejudicially affected by this By-Law and who applies to be heard.
4. THAT this By-Law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.
