

BY-LAW No. 1151

BEING A BY-LAW appointing a Fire Chief and several members of the Fire Department for the City of North Bay.

THEREFORE the Municipal Council of the City of North Bay enacts as follows:-

1. That By-Law Numbers 737, 825, 841, 879, 943, 1109 and all other By-Laws affecting the Fire Chief and several members of the Fire Department, be, and the same are hereby repealed.
2. That G. M. Brady be, and he is hereby appointed Fire Chief.
3. That Walter Wallace be appointed Sub-chief.
4. That Philip Vachon be appointed Captain.
5. That John Boucher, Hector Jessup, George McAra, William Long, Fred Strange and two more to be appointed by the Fire, Water and Light Committee, be appointed regular Firemen.
6. That A. Meecham, O. Bedard, R. Aitkens, be appointed Volunteer Firemen and three others to be appointed by the Fire, Water and Light Committee.
7. That J. Luesby be appointed Janitor.
8. That the salaries of officers and members of the Fire Department be payable on the first and fifteenth of each month and shall be as follows:-
 - (a) The Fire Chief shall be paid at the rate of \$1,500.00 per annum.
 - (b) The Sub-Chief shall be paid at the rate of \$1,200.00 per annum.
 - (c) The Captain shall be paid at the rate of \$1,080.00 per annum.
 - (d) Each regular Fireman shall be paid \$1,020.00 per annum.
 - (e) Each Volunteer Fireman shall be paid \$120.00 per annum.
 - (f) The Janitor shall be paid \$360.00 per annum.
9. One-quarter of one month's salary shall be retained from each member of the Fire Department as security for regular payments on fixed dates.
10. That a bonus of \$1.00 will be paid to each Volunteer Fireman for each call when hose is stretched but no allowance shall be made for stretching hose shall exceed \$5.00 per month per man.
11. That the Fire Chief will have supervision over the staff, will discipline upon the approval of His Worship the Mayor or Chairman of the Fire, Water and Light Committee and may suspend for cause any member of the Fire Brigade and report same at once to the Chairman of the Fire, Water and Light Committee.
12. That the Fire Chief will see that all appliances used for fire fighting are kept in good order and that the building is kept in a clean and sanitary condition including beds and bedding.
13. That he will arrange his staff to have a night staff of eight men with at least one officer on duty.

14. That he will make such arrangements as may be necessary to allow each of his men one day off duty in each week.

15. That he will personall inspect all business premises and public buildings to see that rubbish and inflammable materials are properly kept and also that buildings where public entertainments are held have proper entrances and exits.

16. He will see that equipment for extinguishing fires is kept in all public buildings.

17. He will attend on all schools to see that they have practical fire drill.

18. He will hold fire drill in his department and see that his men are addressed on approved methods of fire fighting, life saving, property saving and first aid.

19. That he will allow the men free use of the dormitory to hold meetings of their Craft Union and allow the members of the Fire Department to attend such meetings when it does not interfere with their duties.

20. That he will send to the Fire, Water and Light Committee of the City Council on the first of each month a written report setting our the activities of the Fire Department together with suggestions for the improvement of the service.

21. That he will see that no fire fighting equipment is used for anything but fire fighting or drill and that he will not absent himself from duty by the authority of His Worship the Mayor or the City Council.

This By-Law shall come into effect on the 5th. day of March, 1934.

Read a Second Time in Open Council this 5th. day of March, 1934.

Rules of Order were suspended and By-Law was read a Third Time short and passed this 5th. day of March, 1934.
