## THE CORPORATION OF THE CITY OF NORTH BAY

## **BY-LAW NO. 62-96**

## BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 131-93 (WINTER PARKING, REGISTERED GROSS WEIGHT, LOADING ZONES, NO PARKING AND SPEED LIMITS)

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45 authorizes the Council to pass bylaws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. Section 1 of Traffic By-Law No. 131-93 is hereby amended as follows:
  - (1) Paragraph J, (Gross Weight) is hereby deleted and the following inserted in lieu thereof:
    - "Gross Weight" means the registered gross weight of the vehicle.
  - (2) Paragraph T (Overnight Parking) is hereby deleted and the following inserted in lieu thereof:
    - "Overnight Parking" means parking a vehicle on any street of the City between the hours of 3:00 a.m. and 6:00 a.m.
- 2. Paragraph 15 of Section 7 of Traffic By-Law No. 131-93 is hereby amended by deleting the paragraph and inserting the following in lieu thereof:
  - "For overnight parking on any street between the hours of 3:00 a.m. and 6:00 a.m. during the period from November 1, to March 31, both inclusive".
- 3. Paragraph 20 of Section 7 of Traffic By-Law No. 131-93 is hereby amended by deleting the paragraph and inserting the following lieu thereof:
  - "Within 4 hours of posting of snow removal signs on any street during the period from November 1 to March 31, both inclusive."
- 4. Paragraph 19 of Section 7 of Traffic By-Law No. 131-93 (No Parking Within 48 Hours of Snowfall) is hereby deleted.
- 5. That Schedule 16 (Loading Zones) to Traffic By-Law No. 131-93 be amended by deleting the following:

Street	Side	<u>Between</u>
13. Main Street	South	60 metres east of Fisher Street and 80 metres east of Fisher Street

6. That Schedule 2 (No Parking Any Time) to Traffic By-Law No. 131-93 be amended by adding the following:

Section F Road Side Between

5. Fee Street East Main Street northerly to end of roadway

7. That Schedule 14 (Speed Limits) of Traffic By-Law No. 131-93 be amended by adding the following:

B - Lower Rate of Speed

Road Between Kilometres per hour

21. Wickstead Ave. Mountainview Drive and Sage Rd. 40 km/hr

8. This By-Law comes into effect upon being passed.
