BY-LAW NO. 144-86

BEING A BY-LAW OF THE CITY OF NORTH BAY TO AUTHORIZE THE MAYOR AND CLERK TO EXECUTE AN AGREEMENT, NORTH BAY WATER WORKS - PROJECT NO. 6-0058-6000.

WHEREAS an Agreement was entered into by the Ontario Water Resources Commission and the Township of West Ferris on July 27, 1961, to provide for a water works;

AND WHEREAS the capital cost of the water works in the amount of \$66,760.96 has now been recovered and the City of North Bay is now operating the water works;

AND WHEREAS the Agreement provides that it shall remain in force for thirty calendar years following the date of completion of the water works;

AND WHEREAS nothing remains to be done under the Agreement;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- That the Mayor and Clerk are hereby authorized to execute an Agreement in the form attached as Schedule "A".
- 2. Section 3 of Frontage Rate By-law 739 dated October 2, 1962 of the Township of Widdifield is hereby amended to delete "30 years" and to insert in lieu thereof "25 years".
- 3. The costs of operation and maintenance will be raised by a service charge upon the urban area pursuant to By-law No. 68-71 as amended from time to time.
- 4. That no part of this by-law comes into force without the approval of the Ontario Municipal Board, but subject to this approval, this by-law takes effect as of December 31, 1986.

HER MAJESTY THE QUEEN IN RIGHT OF ONTARIO AS REPRESENTED BY THE MINISTER OF THE ENVIRONMENT (hereinafter called the "Crown") OF THE FIRST PART J

- and -

The Corporation of the City of North Bay (hereinafter called the "Municipality") OF THE SECOND PART

WHEREAS pursuant to an Agreement dated the 21st day of July, 1961 between the Ontario Water Resources Commission and the Corporation of the Township of West Ferris, a water works (Project No. 6-0058-6000) was provided for the Municipality; and

WHEREAS pursuant to the Government Reorganization Act, 1972, the Crown is the successor to the Ontario Water Resources Commission; and

WHEREAS the Municipality is the successor to the Corporation of the Township of West Ferris; and

WHEREAS the capital cost of the water works has now been recovered and the Municipality is now operating the water works; and WHEREAS the agreement provides that it shall remain in force for thirty calendar years following the date of completion of the water works; and

WHEREAS it is desirable to terminate the agreement as nothing remains to be done under it;

THE PARTIES HERETO AGREE pursuant to section 7(2) and 8 of the Ontario Water Resources Act as follows:

- Section 3(b) of the agreement dated July 27, 1961 is amended by replacing the words "for thirty calendar years" with the words "until the first day of January 1986".
- 2. The Crown hereby certifies that all the obligations of the Municipality to the Ontario Water Resources Commission and the Crown pursuant to these agreements have been discharged to the satisfaction of the Minister.

3. The Crown will execute at the expense of the Municipality such further and other assurance as counsel may advise and the Crown agrees with respect to any property held by the Crown for the sole purpose of the water works.

The agreement dated July 27, 1961, is hereby terminated.
