

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2273

Being a By-law designating that part of registered plan of subdivision no. 38 for the City of North Bay, hereinafter more particularly described, which shall be deemed not to be a registered plan of subdivision for the purposes of Section 26(1) of The Planning Act R.S.O. 1960 Chapter 296, as amended, and designating such area as an area of subdivision control pursuant to the provisions of Section 26(1) of The Planning Act aforesaid; and

Being a By-law designating that part of registered plan of subdivision no 15 for the City of North Bay comprising lots nos. B.D.E. and 48 which shall be deemed not to be a registered plan of subdivision for the purposes of Section 26(1) of The Planning Act aforesaid, and designating such area as an area of subdivision control pursuant to the provisions of Section 26(1) of The Planning Act aforesaid;

WHEREAS the Council of The Corporation of the City of North Bay deems it advisable to enact the within By-law:

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Pursuant to the provisions of The Planning Act R.S.O. 1960 Chapter 296 Section 26(2) as amended, plan of subdivision no. 38 for the City of North Bay registered in the Registry Office for the District of Nipissing at North Bay, Ontario, with the exception of lots 65 to 83, both inclusive, shall be deemed not to be a registered plan of subdivision for the purposes of Section 26(1) of The Planning Act aforesaid.
2. The area of land referred to in paragraph 1 of this By-law is hereby designated as an area of subdivision control, pursuant to the provisions of Section 26(1) of The Planning Act aforesaid.
3. Pursuant to the provisions of Section 26(2) of The Planning Act aforesaid, that part of registered plan of subdivision 15 of the City of North Bay, registered in the Registry Office for the District of Nipissing at North Bay, Ontario, comprising lots nos. B.D.E. and 48 shall be deemed not to be a registered plan of subdivision for the purposes of Section 26(1) of The Planning Act aforesaid.
4. The area of land referred to in paragraph 3 of this By-law is hereby designated as an area of subdivision control, pursuant to the provisions of Section 26(1) of The Planning Act aforesaid.

READ A SECOND TIME IN OPEN COUNCIL THIS 2ND DAY OF MAY, 1966.
