McIntosh, Duncan A. Campbell and Joseph E. Cholette (who propose to form The North Bay Rink and Auditorium Company Limited) the following lots:- 85, 86 and the North 18 feet of Lot 87 King Street; 128, 127 and the North 18 feet of Lot 126 on Victoria Street, North Bay, requires for its validity the consent of the electors and it is expedient and necessary to pass this By-Law for the purpose of enabling the electors to vote on the proposed By-Law.

BE IT THEREFORE ENACTED BY THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY AS FOLLOWS:-

1. THAT the City Clerk shall be the returning officer for the taking of said vote.

2. THE votes of the electors of the Corporation of the City of North Bay shall be taken upon the said proposed By-Law on the 21st. day of February, 1934, and the Returning Officer shall appoint the deputy returning officers to take the necessary vote at the following places:-

3. On the 14th. day of February, 1934, at the hour of two o'clock in the afternoon, the head of the Council of the said Corporation or some member of said Council appointed for that purpose by resolution shall attend at the City Hall, in the Municipality for the purpose of appointing, and if, requested so to do, shall appoint by writing signed by him, two persons to attend at the final summing up of the votes by the Clerk, and one person to attend at each polling place on bahalf of the persons interested in and promoting the proposed By-Law and a like number on behalf of the persons interested in and opposing the proposed By-Law.

4. On the 22nd. day of February, 1934, at the hour of twelve o'clock noon, the Clerk of the said Municipality shall attend and sum up the votes given for and against the proposed By-Law.

5. The polls shall be open from 9 A.M. till 6. P.M. on the 21st. day of February, 1934.
