## BY-LAW NO. 2118

A BY-LAW OF THE CITY OF NORTH BAY to amend By-law No. 2058, a by-law to authorize the leasing of certain lands and the improving of such land where vehicles may be parked.

WHEREAS it is deemed necessary to amend By-law No. 2058 to alter the annual repayment periods so that payment of the loan becomes due and payable at the end of the first fiscal year following the effective date of the loan and in each subsequent year 1964 to 1968.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

THAT Clause No. 7 be amended in the last line to read "Years 1964 to 1968" so that the clause now reads -1.

For the purpose of carrying on the work afore-said the Corporation shall borrow by way of Promissory Note, a sum not exceeding Twenty-nine Thousand, Five Hundred Dollars (\$29,500.00) at 6% interest per annum repayable in five instal-ments in each of the years 1964 to 1968."

2. THAT this by-law shall not come into effect until approval has been granted by the Ontario Municipal Board.


