

BY-LAW NO. 2246

BEING A BY-LAW to amend By-law 1896, a by-law to regulate traffic within the limits of the City of North Bay.

Whereas it is deemed necessary to amend said By-law 1896.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT Schedule "C" (THROUGH STREETS) of By-law 1896 be amended by deleting therefrom -

McIntyre Street	At every intersecting street between Algonquin Ave. and Nipissing Street .
-----------------	----------------------------------------------------------------------------

and adding:-

McIntyre Street	At every intersecting street between Algonquin Avenue and Timmins Street.
-----------------	---------------------------------------------------------------------------

and

Timmins Street	At McIntyre Street
----------------	--------------------

2. THAT Schedule "F" (PARKING PROHIBITED AT ANY TIME) of said By-law 1896 be amended by adding thereto -


(a) Cassells St.	South-East side	King Street to a point 160' westerly.
(b) Main Street	North-East side	Plouffe Street to Murray Street.
(c) Third Avenue	North-East side	Ferguson Street to Fraser Street

3. THIS by-law shall come into force and effect on the date when final approval has been secured from The Ontario Department of Transport.

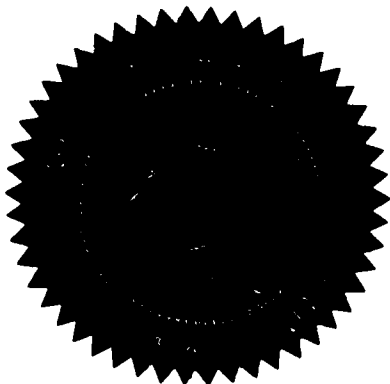
