

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 80-68

BEING A BY-LAW APPOINTING THE DAY AND PLACES FOR TAKING THE VOTES OF THE MUNICIPAL ELECTORS OF THE CITY OF NORTH BAY, PURSUANT TO THE PROVISIONS OF BY-LAW NO. 79-68 OF THE CORPORATION OF THE CITY OF NORTH BAY REQUIRING THE SUBMISSION TO A VOTE OF THE MUNICIPAL ELECTORS AFORESAID, FOR THEIR ASSENT, PROPOSED BY-LAW NO. 78-68 AUTHORIZING THE CORPORATION OF THE CITY OF NORTH BAY TO ENTER INTO AN EXCLUSIVE FRANCHISE AGREEMENT WITH CHARTERWAYS LIMITED:

AND BEING A BY-LAW APPOINTING THE DAYS AND THE PLACES FOR TAKING THE VOTES OF MUNICIPAL ELECTORS AT THE ADVANCE POLLS;

AND BEING A BY-LAW AUTHORIZING THE PUBLICATION OF PROPOSED BY-LAW NO. 78-68 PURSUANT TO THE MUNICIPAL FRANCHISES ACT, R. S. O. 1960, c. 225, sec. 3 (1) AND THE MUNICIPAL ACT, R.S.O. 1960, c. 249, sec. 257 (5);

AND BEING A BY-LAW TO APPOINT A DEPUTY RETURNING OFFICER AND A POLL CLERK FOR EACH POLLING PLACE,

AND BEING A BY-LAW APPOINTING THE TIME WHEN, AND THE PLACE WHERE, THE CLERK WILL SUM UP THE NUMBER OF VOTES GIVEN FOR AND AGAINST THE PROPOSED BY-LAW, THE TIME AND PLACE FOR THE APPOINTMENT OF PERSONS TO ATTEND AT THE POLLING PLACES AND THE TIME AND PLACE FOR THE APPOINTMENT OF PERSONS TO ATTEND AT THE FINAL SUMMING UP OF THE VOTES BY THE CLERK.

Whereas By-law No. 79-68 of The Corporation of the City of North Bay, authorizes and requires the submission to a vote of the Municipal Electors of the City of North Bay, for their assent, Proposed By-law No. 78-68 of The Corporation of the City of North Bay authorizing The Corporation of the City of North Bay to enter into an exclusive Franchise Agreement with Charterways Limited, upon and subject to the terms and conditions set forth in the said Agreement, being Schedule "A" attached to and forming part of Proposed By-law No. 78-68.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY, PURSUANT TO THE MUNICIPAL FRANCHISES ACT, R.S.O. 1960, c. 255, sec. 3 (1) AND THE APPLICABLE PROVISIONS OF THE MUNICIPAL ACT, R.S.O. 1960, c. 249, AS AMENDED, AND PURSUANT TO THE PROVISIONS OF BY-LAW NO. 79-68 AFORESAID, HEREBY ENACTS AS FOLLOWS:

1. That Proposed By-law No. 78-68 of The Corporation of the City of North Bay authorizing The Corporation of the City of North Bay, with the assent of The Municipal Electors, to enter into an exclusive Franchise Agreement with Charterways Limited, be submitted to a vote of the Municipal Electors of the City of North Bay, for their assent, on Monday, the 21st day of October, 1968 between the hours of 11:00 A.M. and 7:00 P.M. Daylight Saving Time.

2. That a copy of Proposed By-law N. 78-68 of The Corporation of the City of North Bay be published in the following issues of "The North Bay Nugget", a daily newspaper published in the City of North Bay, namely:

- Saturday, September 28th, 1968
- Saturday, October 5th, 1968
- Saturday, October 12th, 1968.

3. (a) That the places shown in Schedule "A" attached hereto and forming part of this By-law be appointed and provided for taking the votes of the Municipal Electors on Monday, October 21st, 1968.
- (b) That the Deputy Returning Officers and Poll Clerks as set out in Schedule "A" attached hereto and forming part of this By-law be appointed for the respective Polling Places as set out in the said Schedule "A".

4. That the following days and hours be appointed for Advance Polls for the purpose of receiving the votes of Municipal Electors pursuant to and in accordance with the provisions of Section 90 (1) of The Municipal Act aforesaid:

That Wednesday, the 23rd day of October, 1968, at the hour of 12:00 noon Daylight Saving Time, at the Council Chambers, in the City Hall, in the City of North Bay, be appointed the day, time and place where the City Clerk will sum up the number of votes given for and against the Proposed By-law.


