BEING A BY-LAW of the Corporation of the <sup>C</sup>ity of North Bay requiring the closing of Gasoline Service Stations during certain hours.

WHEREAS for the purpose of this By-law Gasoline Service Stations shall mean a retail gasoline service station, gasoline pump or outlet in the retail gasoline service industry as defined in the Industrial Standards Act.

AND WHEREAS for the purpose of this By-law wherever an expression of time occurs it shall be taken to mean Standard Time or Daylight Saving Time, which ever system of time is currently in use.

THEREFORE THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. That all Gasoline Service Stations within the City of North Bay shall be closed at the hour of seven (7) O'clock in the afternoon of each day in each week of the year and said shops shall remain closed from the said hour of seven (7) o'clock in the afternoon until seven (7) o'clock on the following morning.
- 2. That all Gasoline Service Stations within the City of North Bay shall be closed between the hours of seven (7) o'clock on the afternoon of Saturday and seven (7) o'clock in the forenoon of Monday next following in each and every week during each and every year.
- 3. That an Advisory Committee to consist of the Chief Constable of the City of North Bay, the President of the North Bay Gasoline Retailers Association, and one member of the North Bay City Council, be established for the purpose of recommending that certain Gasoline Service Stations be allowed to remain open during certain hours as hereinafter specified.
- 4. Notwithstanding anything heretoforé contained in this By-law, the Chief Constable is hereby authorized to issue, upon the recommendation of the said Committee, permits to allow certain Gasoline Service Stations to be and remain open during the part or parts of the day or days specified in the permit which permit may only be issued in accordance with certain regulations and restrictions as follows, namely:
  - (a) Permits for Sunday may be issued only for the period from seven (7) O'clock in the forenoon to seven (7) O'clock in the afternoon for the Sunday specified therein.
  - (b) Permits for Sunday may be issued at the discretion of the Advisory Committee and shall be issued in turn to each and every Gasôline Service Station in the City of North Bay, in accordance with a system of rotation to be established by the said Advisory Committee.
  - (c) Permits may be issued for any part of any day or days to not more than five per centum of the gasoline service stations within the Municipality for the supply of emergency services only.
- 5. That the provisions of any previous By-laws and any amendments thereto inconsistent with the provisions of this By-law are hereby repealed.
- 6. That this By-law shall take effect on the date of the passing thereof and shall be subject to the provisions of the Factory, Shop & Office Building Act.
- 7. That every person who contravenes any of the provisions of this By-law shall, upon conviction thereof, forfeit and pay, at the discretion of the <sup>C</sup>onvicting Magistrate, a penalty not exceeding (exclusive of costs) the sum of \$50.00 for each offence.
