- (ii) cancel the 2021 and 2022 increases, which would result in approximately 11 cents being added to the cost of a litre of gas in just 4 years.

And Further that a copy of this resolution be sent to to the Prime Minister of Canada, the Honourable Justin Trudeau, MP Anthony Rota; Leaders of the Opposition, MPP Victor Fedeli, the Association of Municipalities of Ontario, the Federation of Northern Ontario Municipalities and neighbouring Municipalities for their support.
