The General Government Committee presents Report No. 2005-01 and recommends:

- 1. That the 2005 Operating Budget in the amount of \$90,614,459 (excluding water and sanitary sewer expenditures in the amount of \$12,156,066) with a resultant tax levy of \$54,251,334 be approved **(Schedule A)**.
- 2. That budget adjustments summarized on the attached **Schedule B**, resulting in a net decrease in the tax levy totaling \$2,821,245 from the Preliminary Operating Budget, be included in the Operating Budget.
- 3. That the Chief Financial Officer be authorized to process all transfers to and from reserve funds included in the 2005 Operating Budget, including a transfer of \$400,000 from the Tax Rate Stabilization Reserve Fund.
- 4. That the Chief Financial Officer be authorized to process the following year-end transfers to reserve funds as at December 31, 2004.

 b. Tax Policy Development Reserve Fund

e. And that any remaining year-end surplus (or deficit) be transferred to (or from) the Tax Rate Stabilization Reserve Fund. The anticipated year-end surplus, subject to year-end audit, is \$100,000.

- 5. That the levies of all Agencies, Boards and Commissions totaling \$34,623,734 as summarized on the attached **Schedule C** be included in the tax levy.
- 6. That the Chief Financial Officer be authorized to transfer \$4,263,000 from the Operating Fund to the Capital Fund to finance approved capital projects that would otherwise require debenture issuance to fund (Net Capital Levy in Operating Budget).
- 7. That the tax rates included on **Schedule D** be adopted for the 2005 taxation year, subject to confirmation of the education rates from the Province.
- 8. That the due date for the final property tax installment be set at June 30 for the 2005 taxation year.

    - ii) Apply a minimum increase threshold of \$250 to all capped classes;
  - f) That the cost of providing the legislated caps on assessment related increases for individual properties be funded as follows:
    - i) In the Commercial Class the cost be borne from within the class;
    - ii) In the Industrial and Multi-Residential Classes the cost be funded 100% from the Tax Policy Development Reserve Fund;
  - g) That the Long-Term Tax Policy be adopted that includes the following goals and implementation plans:
    - i) Reduce the tax ratios for the Multi-Residential and Commercial Class to 1.400 over a twenty-five year period;
    - ii) Reduce tax ratios only if the tax burden shift can be offset by real

- assessment growth;
- iii) Includes a consideration each year to transfer "excess" supplementary taxes in the Multi-Residential and Commercial Classes to a Tax Policy Development Reserve Fund;
- iv) Accelerates the movement toward full Current Value Assessment for all properties in the capped classes utilizing the capping options available;
