

RECOMMENDATION

That Council authorize an application for approval of set fines and short form wordings for offences contrary to the Smoking By-Law as set out in Schedule "A" of Report to Council No. CORP-2012-49.

BACKGROUND

The Smoking By-Law was passed on Monday, March 5, 2012. The purpose of seeking approval for set fines and short form wordings is to allow the City of North Bay to enforce the Smoking By-Law by writing Certificate of Offence Notices (tickets) under Part I of the *Provincial Offences Act*. This ticketing process is the same process that occurs when a person receives a speeding ticket. It allows for a more expeditious process and allows the defendant the opportunity to pay the fine out of court if they wish. The City of North Bay always has the option not to use the ticketing process despite the availability of set fines and short form wordings and would then proceed to charge pursuant to Part III of the *Provincial Offences Act* which requires the issuing of an Information and a Summons to the Defendant. This process does require the defendant to appear in court. This process can be used for a variety of reasons instead of a Part I ticket (ie: 30 day time limitation period for issuing a Part I ticket has passed; the City of North Bay expects to seek a fine greater than \$1,000.00 due to the seriousness of the offence; a repeat offender; etc.)

In order to use set fines the City of North Bay must obtain approval from the Regional Senior Justice of the Ontario Court of Justice for the Northeast Region. The proposed set fines must first be sent to the Ministry of the Attorney General, Crown Law Office – Criminal prior to being sent to the Regional Senior Justice. The entire approval process can take anywhere from one month to six months.

ANALYSIS/OPTIONS

- 1. To authorize an application for the approval of additional set fines and short form wordings. This would allow The Corporation of the City of North Bay to enforce the Smoking By-Law by writing Certificate of Offence Notices (tickets) under Part I of the *Provincial Offences Act*.
- 2. Not to authorize an application for the approval of set fines and short form wordings. The Corporation of the City of North Bay would be unable to enforce the Smoking By-Law by writing Certificate of Offence Notices (tickets) under Part I of the *Provincial Offences Act*. The By-Law could still be enforced by the laying of an Information pursuant to Part III of the *Provincial Offences Act*. However, the Part III option is normally more time consuming for the enforcement officer and it does not allow the defendant to pay the fine out of court.

Recommendations

- That the proposed Zoning By-law Amendment application by North Bay Daycare on behalf of The Trustees of the Laurier Avenue North Bay Congregation of the United Church of Canada to rezone the property legally described as Registered Plan No. 56, Part Lot 38, from a 'Residential Third Density (R3)' zone to a 'Residential Third Density Special Zone No. 128 (R3 Sp.128)', BE APPROVED; and
- 2. That the subject property be placed under Site Plan Control pursuant to Section 41 of the Planning Act, R.S.O., 1990 as amended in order to regulate parking, lighting, landscaping, storm water, drainage, garbage, play space, ingress, egress and fencing as required.

<u>Site</u>

The subject lands are legally described as Registered Plan No. 56, Part Lot 38 and are located at 449 Laurier Avenue in the City of North Bay. This is the site of the soon-to-be-closed Laurier Avenue United Church.

The surrounding land uses are primarily residential and include semi-detached dwellings, single family detached dwellings and commercial properties fronting on Fisher Street. Chippewa Creek, the Kinsmen Trail and the Fisher Street Parkette are in close proximity to the subject lands, as is the North Bay Daycare main location at the corner of Haig and Fisher Streets, as shown on Schedule 'A' attached hereto.

Proposal

The Applicant, North Bay Daycare on behalf of The Trustees of the Laurier Avenue North Bay Congregation of the United Church of Canada, has submitted a Zoning By-law amendment application to rezone the subject property from a 'Residential Third Density (R3)' zone to a 'Residential Third Density Special Zone No. 128 (R3 Sp.128)' in order to permit the conversion of the Church into a Day Nursery. The special component of the proposed amendment will add 'Day Nursery' to the list of permitted uses and will recognize existing setbacks and lot coverage on the subject lands.

Official Plan

The property is currently designated 'Residential' on Schedule "1" of the City of North Bay's Official Plan.

Section 2.1 of the Official Plan, Settlement Areas, states that: "Infill and intensification developments will be primarily encouraged in the Central Business District (CBD) and surrounding neighbourhoods, where appropriate, and where adequate municipal services, facilities, and transit routes exist. Infilling and intensification will also be promoted in other areas of the City where there is appropriate infrastructure and new development or redevelopment is compatible with surrounding land uses."

The area is adequately serviced and the conversion represents an infill opportunity and continued use on what otherwise would be a vacant building. The lower level of the Church has been used as a Day Nursery for nearly two (2) decades. This use was permitted as an accessory use to the main use, which was the Laurier Avenue United Church. Now that the Church is proposed for closure and sale, the proposed rezoning and end use as a Day Nursery should not represent a significant change to the surrounding neighbourhood.

The proposal to rezone the subject property from a 'Residential Third Density (R3)' zone to a 'Residential Third Density Special Zone No. 128 (R3 Sp.128)' in order to permit the conversion of the Church into a Day Nursery on the subject lands is in conformity with the Official Plan.

Zoning By-Law No. 28-80

The subject property is presently zoned "Residential Third Density (R3)" which permits the following uses:

- Single Detached Dwelling (minimum frontage of 13.7m)
- Duplex Dwelling
- Semi-Detached Dwelling
- Group Home Type 1
- Accessory Home Based Businesses
- Parks, Playgrounds & Non-Profit Uses
- Institutional Uses

The Applicant is proposing to rezone the subject lands to a "Residential Third Density Special Zone No. 128 (R3 Sp.128)" which would permit the above uses, will add 'Day Nursery' to the list of permitted uses, and will recognize the existing setbacks and lot coverage on the subject lands.

Correspondence

This proposal was circulated to property owners within 120 metres (400 feet) of the subject lands, as well as to several municipal departments and agencies that may have an interest in the application.

In terms of correspondence received, the Engineering Department, the Secretary-Treasurer of the North Bay Municipal Heritage Committee, the North Bay-Mattawa Conservation Authority and the Ministry of Transportation have indicated they have no concerns or objections to this proposal.

The Chief Building Official and the Chief Fire Prevention Officer advised the following: "Despite the fact that there does not appear to be a change of use, the owners ought to have Building Services and Fire Prevention attend the site. The inspection may result in required upgrades pursuant to the OBC and Fire Code. The upgrades may require a building permit."

Density Special Zone No. 128 (R3 Sp.128)' in order to permit the conversion of the Church into a Day Nursery. The special component of the proposed amendment will add 'Day Nursery' to the list of permitted uses and will recognize existing setbacks and lot coverage on the subject lands at 449 Laurier Avenue in the City of North Bay.

This is the site of the soon-to-be-closed Laurier Avenue United Church. The surrounding land uses are primarily residential and include semi-detached dwellings, single family detached dwellings and commercial properties fronting on Fisher Street. Chippewa Creek, the Kinsmen Trail and the Fisher Street Parkette are in close proximity to the subject lands, as is the North Bay Daycare main location at the corner of Haig and Fisher Streets, as shown on Schedule 'A' attached hereto.

The conversion of the Church into a day nursery will result in development on existing full municipal services. The conversion will trigger a review of the building and property under the Building and Fire Codes of today, thereby ensuring that public safety and security will be adequately addressed. The property will be subject to Site Plan Control, which will regulate parking, lighting, landscaping, storm water, drainage, garbage, play space, ingress, egress and fencing as required. Under the current proposal, no increase in traffic is expected. If a full conversion and use of the upper floor is sought, an appropriate review and amendment to the Site Plan Control Agreement (SPCA) may be required.

It is my professional opinion that the proposed Zoning By-law amendment is in conformity with the Official Plan and the end use is consistent with Provincial Policy, as set out by the Growth Plan for Northern Ontario (GPNO 2011) and the Provincial Policy Statement (PPS 2005).





BACKGROUND

Permission to Hold Event

The O'Canada Day Committee must ask Council for permission to hold the event pursuant to Noise By-Law No. 142-76 (see Attachment 1).

Noise By-law

Under the condition that Council grants the Committee permission to hold the O'Canada Day Event, the event would be eligible to be exempt from the Noise By-Law. This exemption has been granted over the past several years with no complaints regarding the event.

If Council is not satisfied with the requests as presented but wants the event to proceed, Council could grant the request for permission to hold the event (by approving Recommendation 1) and amend the other requests to suit its concerns (by approving Recommendation No. 2 in an amended form). Depending upon the amendments made, the O'Canada Day Committee may need to review its methodology for the undertaking of the event.

Option 3 – Refuse to grant all requests.

Subject: Municipal Alcohol Policy Amendment to include Steve Omischl Sports Field Complex

RECOMMENDATION

That Council approves an amendment to the Municipal Alcohol Policy Regulation 3 to include the Steve Omischl Sports Field Complex as a facility that is eligible to host liquor licensed events.

BACKGROUND

The Steve Omischl Sports Field Complex officially opened August 20, 2011. It has two artificial turf fields, one natural turf field and three ball diamonds. The complex has the quality and capacity to attract large municipal and out-of-town sporting events.

Over the course of the summer approximately 11 ball/soccer/frisbee tournaments are hosted on North Bay sports fields. Some of these events include a beer tent at the main event location. It is anticipated that the adult events which have included the service of alcohol will move to the Omischl Complex because of the number of fields in one place which centralizes tournament games and activities.

In order to have the ability to host liquor licensed events the Steve Omischl Sport Field Complex must be added to the Municipal Alcohol Policy.

Municipal Alcohol Policy

The Municipal Alcohol Policy provides regulations to assist staff and facility users in the management of the service of alcohol in municipal facilities while ensuring the safety of all participants and the protection of its facilities. (Copy attached). The regulations detailed in the Policy adhere to and are in addition to the requirements under Alcohol and Gaming Commission of Ontario (AGCO).

Under Regulation 3 the Policy identifies facilities that are eligible to host events that include the service of alcohol. The following facilities/parks are currently eligible for a special occasion permit:

- West Ferris Centennial Community Centre Hall, Board Room & Arena Floor
- Pete Palangio Arena Lounge and Boardroom
- Thomson Park Shelter Area
- Lee Park
- Memorial Gardens

It is proposed that the Steve Omischl Sport Field Complex be added to this Regulation as a facility where the service of alcohol will be allowed as follows: "That Steve Omischl Sport Field Complex is designated as a park suitable for outdoor licensed functions in designated areas identified and approved by the Director of Parks, Recreation and Leisure Services or designate."

- 4. To provide for a balanced use of alcohol through Special Occasion Permits (SOP) so that alcohol becomes a responsible part of a social function rather than the reason for the function.
- 5. To provide a balance of wet and dry facilities and programs so that consumers, abstainers, adults, youth and families will be adequately serviced and protected.

REGULATION NO. 1: POLICY REVIEW

.

This Policy will be reviewed on an annual basis or as required based on changes to AGCO regulations and /or municipal facility modifications that may impact eligibility for licensing. Major changes to the policy regulations will be sent to City Council for approval.

REGULATION NO. 2: FACILITIES ELIGIBLE FOR SPECIAL OCCASION PERMITS

The following lists facilities that are considered eligible for licensing under a Special Occasion Permit. Granting permission for an SOP function is at the discretion of the Facility Manager depending on the nature of the function, other activities occurring in the facility and a demonstration that the sponsoring organization can manage the function effectively.

REGULATION NO. 3: MUNICIPAL FACILITIES ELIGIBLE FOR LICENSING

SECTION A: WEST FERRIS CENTENNIAL COMMUNITY CENTRE (WFCCC)

- A. That the hall of the West Ferris Community centre (WFCCC) be designated as a suitable facility for licensed functions.
- B. That the arena floor surface of the WFCCC is designated as a suitable facility for licensed functions when the ice surface is covered or removed.
- C. That the boardroom of the West Ferris Arena is designated as a suitable area for licensed functions.

SECTION B: PETE PALANGIO ARENA

- A. That the lounge of the Pete Palangio arena be designated as a suitable area for licensed functions only when both ice surfaces have been rented by adult groups.
- B. That the boardroom of the Pete Palangio arena is designated as a suitable area for licensed functions.

That the dressing rooms of the Veteran's soccer field, the WFCCC arena, Memorial Gardens and the Pete Palangio arena be clearly designated as areas not suitable for drinking alcohol before, during or after sporting events.

SECTION B: OTHER FACILITIES NOT MENTIONED

.

That all other parks, ball fields, play areas and facilities, beaches and green spaces owned and operated by the City of North Bay be designated as areas not suitable for alcohol consumption and licensed events.

SECTION C: CITY HALL AND CITY BUILDINGS

- A. That the municipal council chambers be designated an area not suitable for licensed events.
- B. That the lobby of City Hall and the boardroom on the 5th floor of City Hall be designated as suitable for licensed events.

REGULATION NO. 6: EVENTS NOT ELIGIBLE FOR LICENSES

That all youth events and all minor sports events, including banquets, be designated as events not suitable for alcohol consumption. Associated adult evening social events commencing after 8:30 p.m. will be allowed, however, minors are considered to be any person under the age of 19

REGULATION NO. 7: YOUTH ADMITTANCE TO ADULT EVENTS

That persons under the legal drinking age not be admitted to licensed social events held after 8:30 p.m., being held in municipally owned facilities, except in the case of a family occasion or private function such as a wedding or anniversary celebration.

In the case of day time licensed events such as adult tournaments and special community events, under age youth have permission to enter outdoor licensed areas as long as they are accompanied by a parent or guardian. (This paragraph is in accordance with the policies and regulations of the Alcohol and Gaming Commission of Ontario).

REGULATION NO. 8: SIGNS

That the following signs be prominently displayed during all licensed functions.

A: STATEMENT OF INTOXICATION:

The following statement will appear on a wall sign and may be printed onto serving cups and/or table talkers.

REGULATION NO. 10: PROVIDE LOW AND NON-ALCOHOL DRINKS

That in order to be eligible for a facility rental for a licensed permit event, the sponsor must be able to demonstrate to the satisfaction of the department that low alcohol drinks are available throughout the duration of the event. Non-alcohol drinks must be offered at no charge or at a price substantially lower than charged for alcohol drinks. Food items (i.e. sandwiches, light meals) must be available.

REGULATION NO. 11: SAFE TRANSPORTATION

A. That the event sponsor supervisor will be required by the department to implement the following

DESIGNATED DRIVER

- Advertise the Designated Driver Program and announce during the event.
- Provide non-alcohol drinks (such as coffee, pop, juices) at no charge or at a substantially reduced rate for the designated driver.

ALTERNATIVE TRANSPORTATION OPTIONS

- . Post local taxi phone numbers.
- . Have sponsor drive intoxicated participants home.
- . Call a friend, relative, or taxi to assist intoxicated drivers and/or collect keys upon entry.
- If necessary, call police, warn or apprehend impaired driver.
- . Announce alternate transportation options available during the event.

POLICE SPOT CHECKS

- Promote the importance of leaving the event a sober driver.
- . Post wall and/or table signs and/or print messages on paper serving cups that read:

"The North Bay Police Services and the Ontario Provincial Police appreciates your assistance in reducing impaired driving everywhere and thank you for leaving this event a sober driver."

NOTE: Please see Regulation No. 6 regarding SOBER DRIVER SPOTCHECK AWARENESS

REGULATION NO. 12: EVENT CONTROLS

A. That in order to be eligible to rent a municipal facility for a licensed event, the sponsor must demonstrate to the satisfaction of the department that the alcohol

14. At least one representative from the Parks, Recreation and Leisure Services Department with authority to demand correction and/or shut down an event on behalf of the City, will monitor all S.O.P. events.

- 15. The event sponsor must abide by the rules of the Municipal Alcohol Policy as enforced by the municipal representative.
- 16. Marketing practices, which encourage increased consumption such as oversized drinks, double shots of spirits, pitchers of beer, drinking contests, and volume discounts are not permitted.
- 17. Ticket prices for non-alcohol beverages will be purchased at a reduced rate than that of alcohol beverages.
- 18. If tickets are sold they must be purchased from a designated ticket seller with a maximum of six tickets per purchase.
- 19. Unused tickets are to be redeemable for cash on demand at any time during the event.
- 20. In order to reduce the risk of intoxication and the rate of consumption, staff should encourage participants to consume food, low alcohol beverages, and non-alcohol beverages.
- 21. The Parks, Recreation and Leisure Services Department reserve the right to require the presence of police officers for the duration of an event, the cost of which will be borne by the sponsoring group or individual. The number of officers is to be determined by the City of North Bay Police Administration and or the Parks, Recreation & Leisure Services department.
- 22. There will be no last call announcement or signal signifying that the bar area will be closing.
- 23. A free bar event must have trained servers and floor monitors.
- 24. Weddings and private family functions held in municipally owned facilities fall under the regulations of this policy.
- 25. All event workers must have some form of identification approved by the Parks, Recreation and Leisure Services Department.
- 26. Whenever possible, Police will be notified by the municipal representative or the event sponsor of a potentially risky situation before the situation is out of control.
- 27. Tickets must be purchased no later than 30 minutes prior to bar closing

6. Where underage youth are found to have consumed or to be consuming alcohol at an S.O.P. and non S.O.P. function, the authorities may be called and /or the following procedure may be followed:

.

- **FIRST INFRACTION:** The individual will be turned over to the parent(s) or guardian(s). If a parent or guardian is not available, the police will be called. A registered letter will be sent by the Department to the parent(s)/guardian(s). The individual will also be banned from the licensed area for six (6) consecutive months.
- **SECOND INFRACTION**: The individual will be banned from attending any public functions held in the facility for a period of six (6) consecutive months. A registered letter will be sent by the Department to the parent(s)/guardian(s).
- **THIRD INFRACTION:** Local authorities will be called and the individual will be banned from public functions held in the facility for a minimum of one (1) year. A registered letter will be sent by the Department to the parent(s)/guardian(s).
- 7. Where adults and youth engage in disruptive behaviour at social events, authorities may be called and/or the following procedure may be followed:
- **FIRST INFRACTION**: A letter of warning from the Department will be sent by registered mail. The individual may be automatically suspended from the facility for a period of six (6) consecutive months depending on the severity of the incident.
- **SECOND INFRACTION**: The individual will be suspended from the facility for a period of six (6) consecutive months. A registered letter will be a sent by the Department.
- **THIRD INFRACTION:** The individual will be banned from public functions held in the facility for a period of one (1) year. A registered letter will be sent by the Department.

REGULATION NO. 15: COMMERCIAL LIQUOR LICENSES

That the City of North Bay encourage existing licensed establishments, liquor license applicants and community groups and clubs to develop an in-house operating policy that will guide them in the responsible service of alcohol. This would include the requirement for all staff to be Smart Serve certified.

REGULATION NO. 16: ALCOHOL ADVERTISING

That permanent advertising that promotes the use of alcohol is prohibited in all municipal facilities.

# APPENDIX "B" GUIDELINES FOR SPECIAL OCCASION PERMIT HOLDERS

As the contact person for a Special Occasion Permit, you and your group can be held liable for injuries and damages arising from failure to adhere to the Alcohol and Gaming Commission of Ontario Act. These infractions include serving someone to intoxication, serving someone who is already intoxicated, serving minors and failing to prevent impaired individuals from driving. In order to reduce your group's risk of liability, the following guidelines should be adopted.

- 1. The event sponsor must provide the following to the Parks, Recreation and Leisure Services Department ten (10) days prior to the event:
  - a) A list of event workers with each worker's S.I.P./Smart Serve registration number.
  - b) A Special Occasion Permit obtained from the Alcohol and Gaming Commission of Ontario
  - c) The name(s), if any, of the permit holder's designate(s).

The permit holder of an outdoor event must, at least twenty-one (21) days prior to the event, give written notice of the event to the municipality, the police, fire and health department.

- 2. The person who signs the Special Occasion Permit Application and the rental agreement or designate must attend the event and be responsible for making decisions regarding the operation of the event.
- 3. All event workers, including the sponsor, must refrain from consuming alcohol while on duty at the event.
- 4. A worker who is impaired or intoxicated will not be allowed to be on duty at the event.
- 5. The event sponsor and recreation staff must ensure that the physical setting is safe for both drinkers and non-drinkers.
- 6. The event sponsor and recreation staff must prevent participants from engaging in activities that can harm them or others.

7. The only acceptable form of identification will be a Ontario's driver's license with photo, Canadian passport with a photo, Canadian citizenship card with a photo, Canadian armed forces card with photo or a Liquor Control Board of Ontario BYID photo card.

8. All exits must be supervised by event staff. These staff control access into the licensed areas and ensure alcohol does not leave the licensed area.

- 23. Whenever possible, Police will be notified by the municipal representative or the event sponsor of a potentially risky situation before the situation is out of control.
- 24. Tickets must be purchased no later than 12:30 a.m.
- 25. The bar area will close at 12:45 a.m. and no later than 1:00 a.m.
- 26. All entertainment must be completed by 1:15 a.m. for indoor events or 11:00 p.m. for outdoor events.
- 27. All tables must be cleared by 1:30 a.m.

# APPENDIX "D"

# THE APPLICANT FOR THIS AGREEMENT HEREBY AGREES:

- 1. To use the facilities in a manner that will not disturb the peace and quiet of other persons adjacent to a public facility.
- 2. There will be no screaming, shouting, swearing or use of insulting or obscene language.
- 3. There will be no impending or molesting of other persons in their use of public facilities.
- 4. To be responsible for all damage(s) to the facility or equipment by participants in the event and ensure that any City facilities used, will be properly secured and all lights and appliances turned off before leaving facility.
- 5. To clean the area of refuse and remove any equipment /items at the conclusion of the event.
- 6. The Department reserves the right to require the use of the premises for its purpose upon two days notice to the applicant. The Department reserves the right to cancel any permit.
- 7. If the applicant intends to erect any structure which will require stakes or similar to be put into the ground, the applicant will notify the Department at the time of application, due to electrical, telephone, and water lines below ground, and obtain the approval of the Department in writing. If it is determined that locates are required, the applicant will request them through the utility company (i.e. Bell, Hydro, Union Gas) at least two (2) weeks prior to event.
- 8. If the sale of food is to take place, the Health Unit must be notified and approval granted from the Health Unit.
- 9. A Fire Permit must be obtained from North Bay Fire Prevention Office, for any bonfire open fire in conjunction with the permitted event.
- 10. The Department reserves the right to limit the number of dates for events requested by any one group / individual. Subsequent requests will be considered at the completion of the second event.
- 11. The sale of liquor requires a Special Occasion Permit and compliance with all Alcohol and Gaming Commission of Ontario regulations, as well as City of North Bay Special Occasion Permit guidelines.
- 12. Permission for fireworks must be obtained from City Council. A Fireworks Permit must be obtained, as well as proof of liability insurance, with the City of North Bay named as co-insured in the amount of \$2,000,000. (minimum). Copies of





8. That Section 4.21.1. is hereby deleted and the following inserted in lieu thereof:

"4.21.1 The number of occupants, residing on a permanent basis in an individual dwelling unit, shall not exceed one person for every nine square metres (96.88 sq. ft.) of habitable floor area."

9. That Section 4.21 – Occupancy Standards be amended to add the following:

"4.21.4 The minimum ceiling height in any dwelling unit measured from finished floor to finished ceiling shall not be less than 1.95 metres (6'5"). Doors, means of egress and stair headrooms shall not be less than 1.95 metres in height as well."

"7.7.1 A Property Standards Committee shall be established composed of not fewer than three (3) members appointed by Council."

sale any goods, substances or things, and the storage of building and construction equipment and materials where such operations do not involve the emission of air or water pollutants that exceed the standards set by the appropriate Provincial Regulatory Authority. - Auto Dealerships and Service Establishments
- Body shop
- Bulk sales establishments
- Data processing firm
- Garden centre
- Heavy Equipment Sales and Service
- Heavy Equipment Storage
- Recreational Vehicle and Equipment Sales and Service
- Repair garage
- Self Storage Uses
- Transportation & Communications, Utility Yards, Terminals
- Warehouse and Storage Uses
- Administrative offices or day nursery or both associated with and integral with the main use.
- One (1) apartment unit within the main building for an essential worker,
  owner/operator or caretaker.
- Outdoor storage is permitted, subject to the provisions of Section 7.4.2.5 of the City of North Bay's Zoning By-law.
- 11.4.37.2 b) The special component of the Zoning By-law amendment would limit the permitted uses to the foregoing and would recognize existing deficiencies in the front yard setback from 13.5 metres to the existing 11.0 metres; and the exterior (easterly) side yard setback from 7.0 metres to the existing 3.0 metres.
- 11.4.37.3 The use of land or building in this "Light Industrial Three Special Zone No. 37 (M3 Sp.37)" shall conform to all other regulations of this By-law except as hereby expressly varied."






