"That: 1) In accordance with Provincial Legislation and the City's Sustainable Financial Plan for Water and Wastewater Systems approved by Council, the current policy of recovering all Water and Sanitary System operating, capital and financial costs from user rates be maintained.

- 2) Council approve Water and Waste Water **metered** rate schedule, effective September 1, 2015 calculated on the basis of 60% fixed / 40% volumetric cost recovery model for the residential classification while ICI users rates are calculated on the current basic connection fee with a minimum monthly consumption fee and declining block billing model. This fixed / volumetric model will be adjusted to 50% / 50% in 2017 and 40% / 60% in 2018.
- 3) With the availability of metered water consumption data, and in striving for a more balanced system of charging for water consumption, Council will annually review opportunities to make adjustments in the distribution of water costs taking into consideration the total potential impact on the system. It is expected this process will be completed by 2025.
- 4) With customers having on-line access to consumption information and bill estimator capability, as of July 1, 2015, effective January 2016, monthly water billing will be implemented and with the introduction of electronic monthly billing, customers electing to receive billing by regular mail may be subject to a monthly paper billing fee.
- 5) Subject to meeting all regulations associated to the *Safe Drinking Water Act*, during the annual Capital plan budgeting process, as well as the annual establishment of rates, regular updates with respect to the progress being made to reduce the amount of wasted water will be provided by the City's Engineering Department.

Whereas municipalities have no control over the form of municipal solid waste that is generated from packing and products that enter their jurisdiction;

And Whereas municipal taxpayers bear more than 50% of the cost of waste disposal and recycling of packaging and printed paper in the waste stream, which products are increasingly complex, multi-material and expensive to recycle, reclaim or dispose of;

And Whereas the Minister of the Environment and Climate Change has committed to replacing the current waste diversion legislation, but has not yet introduced replacement legislation to the legislature;

And Whereas producer responsibility provides that producers be responsible for 100% of the costs of certain designated wastes for full cost of end-of-life management for such products and packaging;

And Whereas municipalities should not have to bear the cost of managing the disposal of these materials;

And Whereas waste is a valuable resource;

And Whereas producer responsibility would provide considerable savings to the City of North Bay residents and grow the local economy as producers innovate to reduce waste, develop more easily recyclable packaging and work with municipalities on better ways to collect and process it;

And Whereas increased recycling and reclamation could add 13,000 good, high-quality jobs in Ontario and contribute more than \$1.5 billion every year to Ontario's economy;

Therefore Be It Resolved That the City of North Bay calls on the Ontario Government to introduce legislation to replace the *Waste Diversion Act* with a system based on full Producer Responsibility, ensuring that producers are responsible for 100% of the end-of-life costs of designated waste, and that producers need to work with the municipal sector on those Producer Responsibility programs that affect the municipal integrated waste management system so that municipalities are fairly compensated for services provided to manage designated waste that enters the municipal system;

And Further that a copy of this resolution be forwarded to the Minister of Environment & Climate Change Minister Glen Murray, AMO, FONOM, Stewardship Ontario, the Leaders of Provincial Opposition.

- iv) that staff negotiate a fee for the use of any parking spots utilized in the pilot project;

- v) that a report be prepared by city staff following September 2015, and that this report be shared with the DIA for further review and input; and
- vi) that a final recommendation be presented to Council by February 28, 2016 for consideration.
