### **BY-LAW NO. 2003-62**

## BEING A BY-LAW TO PROVIDE FOR ADVANCE VOTES TO BE HELD PRIOR TO VOTING DAY AND TO PROVIDE FOR REDUCED HOURS OF VOTING IN INSTITUTIONS AND RETIREMENT HOMES

WHEREAS Section 43.(1) of the Municipal Elections Act, S.O. 1996, as amended, provides that a municipal council shall pass a by-law establishing one or more dates for an advance vote, and the hours during which voting places shall be open on that date or dates;

**AND WHEREAS** Section 43.(2) of the *Municipal Elections Act*, S.O. 1996, as amended, provides that a municipal council shall pass a by-law with reduced hours in voting places in retirement homes or those institutions as defined in Section 45.(7) of the said Act, where the voting place is only for the use of the residents;

AND WHEREAS by Resolution No. 2003-295 passed by Council at its Regular Meeting on Tuesday, May 20, 2003 Council authorized a by-law to provide for advance votes to be held prior to Voting Day and to provide for reduced hours of voting in Institutions and Retirement Homes:

## NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- An advance vote shall be held between the hours of 9:00 a.m. and 4:30 p.m. on the main floor at City Hall in the City of North Bay on the following dates:
  - Thursday, October 30<sup>th</sup>, 2003
  - Friday, October 31<sup>st</sup> 2003

  - Saturday, November 1<sup>st</sup> 2003 Monday, November 3<sup>rd</sup>, 2003 Tuesday, November 4<sup>th</sup>, 2003

  - Wednesday, November 5<sup>th</sup>, 2003
  - Thursday, November 6<sup>th</sup>, 2003
  - Friday, November 7<sup>th</sup>, 2003.
- Those voting places as shown in Schedule "A" attached hereto, shall be open for those 2. hours as also detailed in Schedule "A".

READ A FIRST TIME IN OPEN COUNCIL THIS 2<sup>ND</sup> DAY OF JUNE, 2003.

READ A SECOND TIME IN OPEN COUNCIL THIS 2<sup>ND</sup> DAY OF JUNE, 2003.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 2<sup>ND</sup> DAY OF **JUNE**, 2003.
