## THE CORPORATION OF THE CITY OF NORTH BAY

## BY-LAW NO. 2395

WHEREAS the Council of the Municipal Corporation of the City of North Bay deems it advisable to divide the existing three wards into new polling subdivisions.

AND WHEREAS The Municipal Act, R.S.O. 1960, Chapter 249, Section 58(1), authorizes the Council of the local municipality to pass By-Laws for the said purpose of dividing wards into polling subdivisions.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

That Ward l of the City of North Bay be redivided into the following polling subdivisions:

Polling Division No. 1 shall comprise that area bounded as follows: Commencing with the intersection of the centre line of Mattawa Street with the shore line of Lake Nipissing; thence northerly along the centre line of Mattawa Street to the centre line of Jane Street; thence westerly along the centre line of Jane Street to the intersection thereof with the centre line of Gormanville Road; thence northerly along the centre line of Gormanville Road to the northerly limit of Rear Street being also the northerly limit of the City of North Bay; thence westerly along the said northerly limit of the City of North Bay to the shore line of Lake Nipissing; thence easterly along the shore of Lake Nipissing to the point of commencement.

Polling Division No. 2 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Timmins Street with the shore of Lake Nipissing; thence northerly along the centre line of Timmins Street to the centre line of Jane Street; thence westerly along the centre line of Jane Street to the centre line of Clarence Street; thence northerly along the centre line of Clarence Street to the centre line of Vimy Street; thence westerly along the centre line of Vimy Street to the productions southerly of the easterly boundary line of Lot 87 Plan 110, Vimy Street; thence northerly in a straight line to the northeast angle of said Lot 87; thence westerly along the northerly limits of Lots 87, 86, 85, 84, 83, 82 Plan 110, Vimy Street to the northwest angle of Lot 82, Vimy Street; thence southerly along the westerly boundary of said Lot 82 projected to the centre line of Jane Street; thence easterly along the centre line of Jane Street to the centre line of Mattawa Street; thence southerly along the centre line of Mattawa Street to the shoreline of Lake Nipissing; thence easterly along the shoreline of Lake Nipissing to the point of commencement.

Polling Division No. 3 shall comprise that area bounded as follows: Commencing at the southeasterly angle of Lot No. 90, Plan 115, Tackaberry Drive; thence northerly along the boundary between the City of North Bay and the Township of Widdifield to the northerly limit of the said boundary; thence westerly along the northerly limit of the City of North Bay to the intersection thereof with the centre line of Gormanville Road; thence southerly along the centre line of Gormanville Road being also the westerly limit of the City of North Bay to the intersection thereof with the centre line of Jane Street; thence easterly along the centre line of Jane Street to the intersection thereof with the extension southerly of the westerly limit of Lot 35 Plan 114, Jane Street; thence northerly in a straight line to the most northerly angle of Lot 29 Plan 114, Baywood Road; thence easterly and northeasterly along the southerly and southeasterly limits of Block A, Plan 115, to the most northerly angle of Lot 8, Plan 114, Pinewood Crescent; thence southeasterly in a straight line to the intersection of the northeasterly limit of Lot 6 Plan 114, Pinewood Crescent with the northwesterly limit of Lot 135 Plan 110, Pinewood Road; thence northerly in a straight line

to the most northerly angle of Lot 73 Plan 110, Pinewood Road; thence southeasterly in a straight line to the intersection of the westerly limit of Lot 107 Plan 113, Clarence Street by the northeasterly limit of Lot 71 Plan 110, Pinewood Road; thence northerly in a straight line to the most northerly angle of Lot 82 Plan 115, Clarence Street; thence southeasterly in a straight line to the point of commencement.

Polling Division No. 4 shall comprise that area bounded as follows: Commencing at the intersection of the westerly limit of Lot 89 Plan 113, Clarence Street by the northerly limit of Lot 87 Plan 110, Vimy Street; thence northerly in a straight line to the intersection of the westerly limit of Lot 107 Plan 113, Clarence Street with the northerly limit of Lot 71 Plan 110, Pinewood Road; thence northwesterly along the northerly limits of Lots 71, 72 and 73 Plan 110, Pinewood Road to the westerly limit of Lot 34 Plan 115 Cedargrove Drive; thence southwesterly in a straight line to the intersection of the northwesterly limit of Lot No. 135 Plan 110, Pinewood Road by the northeasterly limit of Lot No. 6 Plan 114, Pinewood Crescent; thence northwesterly along the northeasterly limit of Lots Nos. 6, 7 and 8 Plan 114, Pinewood Crescent to the most northerly angle of said Lot No. 8; thence southwesterly and westerly along the southeasterly and southerly limit of Block A Plan 115 to the most northerly angle of Lot 29 Plan 114, Baywood Road; thence southerly in a straight line to the point where the centre line of Jane Street is intersected by the production southerly of the westerly limit of Lot 35 Plan 114, Jane Street; thence easterly along the centre line of Jane Street to the point where it is intersected by the production southerly of the westerly limit of Lot 82 Plan 110, Vimy Street; thence northerly in a straight line to the most northerly angle of said Lot 82; thence southeasterly and easterly along the northerly limits of Lots 82 to 87 Plan 110, Vimy Street to the point of commencement.

Polling Division No. 5 shall comprise that area bounded as follows: Commencing at the southeasterly angle of Lot 90 Plan 115, Tackaberry Drive; thence southerly in a straight line to the point where the centre line of Vimy Street is intersected by the production southerly of the easterly limit of Lot 130 Plan 115, Clarence Street; thence westerly along the centre line of Vimy Street to the production southerly of the easterly boundary of Lot 88 Plan 115, Clarence Street; thence northerly in a straight line to the most northerly angle of Lot 82 Plan 115, Clarence Street; thence easterly in a straight line to the point of commencement.

Polling Division No. 6 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Jane Street with the centre line of Durril Street; thence northerly along the centre line of Durril Street to the centre line of McLaren Street; thence westerly along the centre line of McLaren Street to the centre line of Bloem Street; thence along the centre line of Bloem Street to the intersection thereof with the production southerly of the centre line of Beattie Street; thence northerly along the centre line of Beattie Street to the northerly limit of the City of North Bay; thence westerly along the said northerly limit of the City of North Bay to the intersection thereof with the northerly limit of Lot 125 Plan 115, Clarence Street; thence southerly in a straight line to the intersection of the centre line of Vimy Street with the production southerly of the easterly limit of Lot 130 Plan 113, Clarence Street; thence westerly along the centre line of Vimy Street to the centre line of Clarence Street; thence southerly along the centre line of Clarence Street to the centre line of Street; thence easterly along the centre line of Jane Street; thence easterly along the centre line of Jane Street; thence easterly along the centre line of Jane Street; thence easterly along the centre line of Jane Street to the point of commencement.

Polling Division No. 7 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Timmins Street with the shore of Lake Nipissing; thence northerly along the centre line of Timmins Street to the centre line of Jane Street; thence easterly along the centre line of Jane Street to the centre line of Bell Street; thence southerly along the centre line of Bell Street to the centre line of Main Street; thence westerly along the centre line

of Main Street to the centre line of llth Street; thence southerly along the centre line of llth Street and the production thereof to the shore of Lake Nipissing; thence westerly along the shore of Lake Nipissing to the point of commencement.

Polling Division No. 8 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Algonquin Avenue and the centre line of Jane Street; thence montherly along the centre line of Algonquin Avenue to the City Limits; thence westerly along the City Limits to the centre line of Beattie Street; thence southerly along the centre line of Beattie Street and a production southerly thereof to the centre line of Bloem Street; thence easterly along the centre line of Bloem Street to the centre line of McLaren Street; thence easterly along the centre line of Durril Street; thence southerly along the centre line of Durril Street; thence southerly along the centre line of Durril Street; thence southerly along the centre line of Jane Street; thence easterly along the centre line of Jane Street; commencement.

Polling Division No. 9 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Bell Street with the centre line of Jane Street; thence southerly along the centre line of Bell Street to the centre line of McIntyre Street; thence easterly along the centre line of McIntyre Street to the centre line of Murray Street; thence northerly along the centre line of Murray Street to the centre line of Jane Street; thence westerly along the centre line of Jane Street to the point of commencement.

Polling Division No. 10 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of McIntyre Street with the centre line of Murray Street; thence southerly along the centre line of Murray Street to the centre line of Main Street; thence westerly along the centre line of Main Street to the production northerly of the centre line of 9th Street; thence southerly in a straight line and parallel to the westerly limit of 9th Street to the shore of Lake Nipissing; thence westerly along the shore of Lake Nipissing to the intersection thereof by the production southerly of the centre line of 11th Street; thence northerly in a straight line to the intersection of the centre line of Main Street by the production northerly of the centre line of 11th Street; thence easterly along the centre line of Main Street to the production southerly of the centre line of Bell Street; thence northerly along the centre line of Bell Street; thence northerly along the centre line of McIntyre Street; thence easterly along the centre line of McIntyre Street; thence easterly along the centre line of McIntyre Street; thence easterly along the centre line of McIntyre Street to the point of commencement.

Polling Division No. 11 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Algonquin Avenue with the centre line of Jane Street; thence westerly along the centre line of Jane Street to the production northerly of the centre line of Murray Street; thence southerly along the centre line of Murray Street and the production thereof to the centre line of Main Street; thence westerly to the production northerly of the centre line of 9th Street; thence southerly in a straight line and parallel to the westerly limit of 9th Street to the shore of Lake Nipissing; thence easterly along the shore of Lake Nipissing to the production southerly of the centre line of Wyld Street; thence northerly along the said production of the centre line of Wyld Street to the production southerly of the centre line of Algonquin Avenue; thence northerly in a straight line to the point of commencement.

Polling Division No. 12 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Front Street with the centre line of Algonquin Avenue; thence north along the centre line of Algonquin Avenue to the centre line of High Street; thence east along the centre line of High Street to the centre line of Douglas Street; thence south along the centre line of Douglas Street to the centre line of Front Street; thence west along the centre line of Front Street to the point of commencement.

Polling Division No. 13 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Front Street with the centre line of Douglas Street; thence north along the centre line of Douglas Street to the centre line of High Street; thence east along the centre line of High Street to the centre line of McLeod Street; thence south along the centre line of McLeod Street to the centre line of Front Street; thence west along the centre line of Front Street to the point of commencement.

Polling Division No. 14 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Front Street with the centre line of McLeod Street; thence east along the centre line of Front Street to the centre line of McPhail Street; thence northealong the centre line of McPhail Street to the centre line of High Street; thence west along the centre line of High Street to the centre line of McLeod Street; thence south along the centre line of McLeod Street to the point of commencement.

Polling Division No. 15 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Algonquin Avenue with the centre line of High Street; thence north along the centre line of Algonquin Avenue to the City Limit; thence east along the City Limit to the centre line of Galt Street; thence south along the centre line of Galt Street to the centre line of High Street; thence west along the centre line of High Street to the point of commencement.

Polling Division No. 16 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of High Street with the centre line of Galt Street; thence easterly along the centre line of High Street to the centre line of O'Brien Street; thence northerly along the centre line of O'Brien Street to the City Limit; thence westerly along the City Limit to the centre line of Galt Street; thence southerly along the centre line of Galt Street to the point of commencement.

Polling Division No. 17 shall comprise that area bounded as follows: Commencing at the intersection of the northerly limit of the City of North Bay with centre line of O'Brien Street; thence southerly along the centre line of O'Brien Street to the centre line of High Street; thence easterly along the centre line of High Street to the centre line of McPhail Street; thence southerly along the centre line of McPhail Street to the centre line of Cassells Street; thence easterly along the centre line of Cassells Street to the centre line of Princess Street; thence northerly along the centre line of Princess Street to the centre line of High Street; thence easterly along the centre line of High Street to the centre line of Chippewa Street; thence northerly along the centre line of Chippewa Street to the northerly limit of the City of North Bay; thence westerly in a straight line to the point of commencement.

Polling Division No. 18 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Princess Street with the centre line of Cassells Street; thence easterly along the centre line of Cassells Street to the intersection thereof with the centre line of Trout Lake Road; thence along the centre line of Trout Lake Road to the centre line of the North Bay By-Pass; thence north-westerly along the centre line of the North Bay By-Pass to the City Limit; thence westerly along the City Limit to the centre line of Chippewa Street; thence south along the centre line of Chippewa Street to the centre line of Princess Street; thence south along the centre line of Princess Street; thence south along the centre line of Princess Street; thence south along

Polling Division No. 19 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of the North Bay By-Pass with the centre line of Trout Lake Road; thence northeasterly along the centre line of Trout Lake Road to the centre line of McKay Avenue; thence north along the centre line of McKay Avenue to the City Limit; thence west along the City Limit to the centre line of the North Bay By-Pass; thence southeasterly along the centre

line of the North Bay By-Pass to the point of commencement.

Polling Division No. 20 shall comprise that area bounded as follows: Commencing at the intersection of the centre lines of Cassells Street and Trout Lake Road; thence easterly along the production easterly of Cassells Street to the easterly limit of the City of North Bay; thence northerly along the easterly limit of the City of North Bay to the northerly limit; thence westerly along the northerly limit to the centre line of McKay Avenue; thence southerly along the centre line of McKay Avenue to the centre line of Trout Lake Road; thence southwesterly along the centre line of Trout Lake Road to the point of commencement.

That Ward 2 of the City of North Bay be redivided into the following polling subdivisions.

Polling Division No. 21 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Algonquin Avenue with the centre line of Cassells Street; thence north along the centre line of Algonquin Avenue to the centre line of Front Street; thence east along the centre line of Front Street to the centre line of Second Avenue; thence south along the centre line of Second Avenue to the centre line of Cassells Street; thence southwesterly along the centre line of Cassells Street to the point of commencement.

Polling Division No. 22 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Second Avenue with the centre line of Cassells Street; thence east along the centre line of Cassells Street to the centre line of Front Street; thence west along the centre line of Front Street to the centre line of Second Avenue; thence south along the centre line of Second Avenue to the point of commencement.

Polling Division No. 23 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Cassells Street with the centre line of King Street; thence south along the centre line of King Street to the centre line of Fraser Street; thence west along the centre line of Fraser Street to the centre line of Third Avenue; thence north along the centre line of Third Avenue to the centre line of Cassells Street; thence east along the centre line of Cassells Street to the point of commencement.

Polling Division No. 24 shall comprise that area bounded as follows: Commencing at the centre line of Princess Street and the centre line of Cassells Street; thence southerly along the centre line of Princess Street to the centre line of Fraser Street; thence easterly along the centre line of Fraser Street to the centre line of Chippewa Street; thence southerly along the centre line of Chippewa Street to the centre line of Wyld Street; thence easterly along the centre line of Wyld Street to the centre line of Aubrey Street; thence southerly along the centre line of Aubrey Street and the production southerly thereof to the centre line of Fisher Street; thence easterly along the centre line of Fisher Street and continuing along the boundary between Wards 2 and 3 to the easterly limit of the City of North Bay; thence northerly along the easterly limit of the City of North Bay to the intersection thereof with the production easterly of the centre line of Cassells Street; thence westerly in a straight line to the intersection of the centre lines of Cassells Street and Princess Street which is the point of commencement.

Polling Division No. 25 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Chippewa Street with the centre line of Fraser Street; thence westerly along the centre line of Fraser Street to the centre line of Princess Street; thence southerly along the centre line of Princess Street to the centre line of Wyld Street; thence easterly along the centre line of Wyld Street to the centre line of Chippewa Street; thence northerly along the centre line of Chippewa Street to the point of commencement.

Polling Division No. 26 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Cassells Street with centre line of Princess Street; thence westerly along the centre line of Cassells Street to the centre line of King Street; thence southerly along the centre line of King Street to the centre line of Wyld Street; thence easterly along the centre line of Wyld Street to the centre line of Princess Street; thence northerly along the centre line of Princess Street to the point of commencement.

Polling Division No. 27 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Fifth Avenue with the centre line of Wyld Street; thence easterly along the centre line of Wyld Street to the centre line of Aubrey Street; thence southerly along the centre line of Aubrey Street and the southerly production thereof to the centre line of Fisher Street; thence westerly along the centre line of Fisher Street to the centre line of Fifth Avenue thence northerly along the centre line of Fifth Avenue to the point of commencement.

Polling Division No. 28 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of King Street with the centre line of Fraser Street; thence southwesterly along the centre line of Fifth Avenue; thence southeasterly along the centre line of Fifth Avenue to the centre line of Wyld Street; thence easterly along the centre line of Wyld Street to the centre line of King Street; thence northerly along the centre line of King Street to the point of commencement.

Polling Division No. 29 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Fifth Avenue with the centre line of Fraser Street; thence westerly along the centre line of Third Avenue; thence southerly along the centre line of Third Avenue to the centre line of Ferguson Street; thence easterly along the centre line of Ferguson Street to the centre line of Fourth Avenue; thence southerly along the centre line of Fourth Avenue to the centre line of Wyld Street; thence easterly along the centre line of Wyld Street to the centre line of Fifth Avenue; thence northerly along the centre line of Fifth Avenue to the point of commencement.

Polling Division No. 30 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Fifth Avenue with the centre line of Wyld Street; thence westerly along the centre line of Wyld Street to the centre line of Fourth Avenue; thence northerly along the centre line of Fourth Avenue to the centre line of Ferguson Street; thence westerly along the centre line of Ferguson Street to the centre line of Third Avenue; thence southerly along the centre line of Third Avenue to the centre line of Fisher Street; thence easterly along the centre line of Fisher Street to the centre line of Fifth Avenue; thence northerly along the centre line of Fifth Avenue to the point of commencement.

Polling Division No. 31 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Third Avenue with the centre line of Cassells Street; thence westerly along the centre line of Cassells Street to the centre line of Algonquin Avenue; thence southerly along the centre line of Algonquin Avenue to the centre line of Fraser Street; thence easterly along the centre line of Fraser Street to the centre line of Third Avenue; thence northerly along the centre line of Third Avenue to the point of commencement.

Polling Division No. 32 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Algonquin Avenue with the centre line of Fraser Street; thence easterly along the centre line of Fraser Street to the centre line of Third Avenue; thence southerly along the centre line of Third Avenue to the centre line of Ferguson Street; thence westerly along the centre line of Ferguson

Street to the production southerly of the centre line of Algonquin Avenue; thence northerly in a straight line to the point of commencement.

Polling Division No. 33 shall comprise that area bounded as follows: Commencing at the intersection of the centre lines of Third Avenue and Ferguson Street; thence westerly along the centre line of Ferguson Street and the production westerly thereof to the production southerly of the centre line of Algonquin Avenue; thence southerly along the said production of the centre line of Algonquin Avenue to the production westerly of the centre line of Wyld Street; thence easterly in a straight line to the intersection of the centre lines of Third Avenue and Wyld Street; thence northerly along the centre line of Third Avenue to the point of commencement.

That Ward 3 of the City of North Bay be redivided into the following polling subdivisions:

Polling Division No. 34 shall comprise that area bounded as follows: Commencing with the centre line of McIntyre Street and the centre line of Wyld Street; thence southerly along the centre line of McIntyre Street to the centre line of Fisher Street; thence easterly along the centre line of Fisher Street to the centre line of Third Avenue; thence northerly along the centre line of Third Avenue to the centre line of Wyld Street; thence westerly along the centre line of Wyld Street; to the point of commencement.

Polling Division No. 35 shall comprise that area bounded as follows: Commencing at the intersection of the productions southerly of the centre line of Regina Street with the shore of Lake Nipissing; thence easterly along the centre line of Regina Street to the centre line of McIntyre Street; thence northerly along the centre line of McIntyre Street to the centre line of Wyld Street; thence westerly along the centre line of Wyld Street and the production westerly thereof to the shore of Lake Nipissing; thence southerly along the shore of Lake Nipissing to the point of commencement.

Polling Division No. 36 shall comprise that area bounded as follows: Commencing at the intersection of the productions southerly of the centre line of Regina Street with the shore of Lake Nipissing; thence easterly in a straight line to the intersection of the centre lines of Regina Street and McIntyre Street; thence southerly along the centre line of McIntyre Street to the centre line of Metcalfe Street; thence westerly along the centre line of Metcalfe Street and the projection westerly thereof to the centre line of Chippewa Creek; thence westerly along the centre line of Chippewa Creek to the shore of Lake Nipissing; thence northerly along the shore of Lake Nipissing to the point of commencement.

Polling Division No. 37 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of John Street with the centre line of McIntyre Street; thence easterly along the centre line of John Street to the centre line of Worthington Street; thence southerly along the centre line of Worthington Street and continuing along the centre line of the Old Callander Road to the City Limit; thence westerly along such limit to the easterly limit of the right-of-way of the Canadian Pacific Railway; thence northerly along the easterly limit of such right-of-way to the centre line of Chippewa Creek; thence easterly along the centre line of Chippewa Creek to the production westerly of the centre line of Metcalfe Street; thence easterly in a straight line to the intersection of the centre line of Metcalfe Street with the centre line of McIntyre Street; thence northerly along the centre line of McIntyre Street; thence northerly along the centre line of McIntyre Street; thence northerly along the centre line of McIntyre Street to the point of commencement

Polling Division No. 38 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of McIntyre Street with the centre line of Fisher Street; thence easterly along the centre line of Fisher Street to the centre line of First Avenue; thence southerly along the centre line of First Avenue to the centre line of John Street; thence westerly along the centre line of John Street to the centre line of McIntyre Street; thence northerly along the centre line of McIntyre Street to the point of commencement.

Polling Division No. 39 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Fisher Street with the centre line of First Avenue; thence southerly along the centre line of First Avenue to the centre line of John Street; thence easterly along the centre line of John Street to the centre line of Third Avenue; thence northerly along the centre line of Third Avenue to the centre line of Fisher Street; thence westerly along the centre line of Fisher Street to the point of commencement.

Polling Division No. 40 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Worthington Street with the centre line of John Street; thence easterly along the centre line of John Street to the easterly limit of the Canadian National Railway right-of-way; thence southerly along the said easterly limit of the said right-of-way to the northerly limit of the right-of-way of the Ontario Northland Railway; thence westerly along such northerly limit of the said right-of-way to the centre line of the Old Callander Road; thence northerly along the centre line of the Old Callander Road and continuing along the centre line of Worthington Street to the point of commencement.

Polling Division No. 41 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Third Avenue with the centre line of Regina Street; thence easterly along the centre line of Regina Street to the centre line of Laurier Avenue; thence southerly along the centre line of Laurier Avenue to the northerly limit of the right-of-way of the Ontario Northland Railway; thence westerly along the said limit of such right-of-way to the easterly limit of the right-of-way of the Canadian National Railway; thence northerly along the said limit of such right-of-way to the centre line of Third Avenue; thence northerly in a straight line to the point of commencement.

Polling Division No. 42 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Third Avenue with the centre line of Hammond Street; thence easterly along the centre line of Hammond Street to the centre line of York Street; thence southerly along the centre line of York Street to the centre line of Regina Street; thence westerly along the centre line of Regina Street to the centre line of Laurier Avenue; thence northerly along the centre line of Laurier Avenue to the centre line of Regina Street; thence westerly along the centre line of Regina Street to centre line of Third Avenue; thence northerly along the centre line of Third Avenue to the point of commencement.

Folling Division No. 43 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Third Avenue with the centre line of Fisher Street; thence easterly along the centre line of Fisher Street to the centre line of York Street; thence southerly along the centre line of York Street to the centre line of Hammond Street; thence westerly along the centre line of Hammond Street to the centre line of Third Avenue; thence northerly along the centre line of Third Avenue to the point of commencement.

Polling Division No. 44 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Ellis Street with the centre line of Depencier Road; thence northerly along the centre line of Ellis Street to the centre line of Regina Street; thence westerly along the centre line of Regina Street to the centre line of Laurier Avenue; thence southerly along the centre line of

Laurier Avenue to the northerly limit of the right-of-way of the Ontario Morthland Railway; thence westerly along such northerly limit of the said right-of-way to the centre line of the Old Callander Road; thence easterly along the centre line of Old Callander Road to the City Limit; thence easterly and northerly along the City Limits to the intersection thereof with the centre line of Seymour Street; thence westerly along the centre lines of Seymour Street and Depencier Road to the point of commencement.

Polling Division No. 45 shall comprise that area bounded as follows: Commencing with the centre lines of Fisher and York Streets; thence southerly along the centre line of York Street to the centre line of Regina Street; thence easterly along the centre line of Regina Street to the centre line of Ellis Street; thence southerly along the centre line of Ellis Street to the centre line of Depencier Road; thence easterly along the centre lines of Depencier Road and Seymour Street to the easterly limit of the City of North Bay; thence northerly along the easterly limit of the City of North Bay to the intersection thereof by the boundary between Wards 2 and 3; thence westerly along the said boundary and along the centre line of Fisher Street to the point of commencement.

Polling Division No. 46 shall comprise that area bounded as follows: Commencing at the intersection of the centre line of Chippewa Creek with the shore of Lake Nipissing; thence easterly along the centre line of Chippewa Creek to the easterly limit of the right-of-way of the Canadian Pacific Railway; thence southerly along the said easterly limit of such right-of-way to the southerly limit of the City; thence westerly along the said limit to the shore of Lake Nipissing; thence northerly along the shore of Lake Nipissing to the point of commencement.

That By-Law No. 1296 and all other By-Laws, or parts of By-Laws inconsistent with this By-Law are hereby repealed.
