By-Law No. 2016-119

**Being a By-Law to Amend By-Law No. 2010-108
(Waste Management By-Law - Schedule "A" and Schedule "D")**

Whereas The Corporation of the City of North Bay (the "City") is the owner and operator of the Merrick Landfill Site located in Merrick Township (the "Landfill Site");

And Whereas the City is authorized to enact by-laws imposing fees or charges for services or activities provided or done by or on behalf of it pursuant to section 391 of the *Municipal Act, 2001* (S.O. 2001, c.25);

And Whereas the City is authorized to regulate and inspect the use of any land or structures within the municipality or any defined area or areas thereof for dumping or disposing of garbage, refuse, or domestic or industrial waste of any kind;

And Whereas the Council deems it desirable to regulate the disposal of garbage by way of landfill bans, recycling and home composting systems;

And Whereas Notice of the Public Meeting in the matter of waste management fees and charges was given by advertisement in the North Bay Nugget on the 22nd day of October, 2016 and the 29th day of October, 2016;

And Whereas a Public Meeting under the *Municipal Act* in the matter of the waste management fees and charges was held on the 21st day of November, 2016;

And Whereas by General Government Committee Report No. 2016-17 passed at its Regular Meeting held on Monday, November 21, 2016 Council authorize a by-law to increase the current fees and charges in place for waste management.

Now Therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

1. Schedule "A" of By-Law No. 2010-108, as amended, is hereby amended as follows:

Waste	January 1, 2017
a) Solid waste from industrial, commercial and institutional sources	\$93.00/tonne (\$20.00 load minimum)
Classifications	Effective Date
Waste	January 1, 2018
a) Solid waste from industrial, commercial and institutional sources	\$96.00/tonne (\$20.00 load minimum)
Classifications	Effective Date
Mattresses/Box Springs	April 1, 2017
s) Mattresses	\$20.00 per mattress
t) Box springs	\$20.00 per box spring"

2. Schedule "D" of By-Law No. 2010-108, as amended, is hereby amended as follows:

"8. Mattresses and box springs."

3. This By-Law comes into force and effect as of January 1, 2017.

Read a Second Time in open Council this 12th day of December, 2016.

Read a Third Time in open Council and passed this 12th day of December, 2016.
