NOW THEREFORE BE IT RESOLVED THAT the Council of the City of North Bay request the Province of Ontario to secure funding for that purpose.

AND WHEREAS the proposal has been submitted to the funding agents to undertake the task of creating a fulfilment bureau and the Chamber is seeking support of all regional partners to ensure this proposal is approved;

BE IT THEREFORE RESOLVED THAT the City of North Bay, through the Mayor and Council, provide a letter of support to the Chamber for this initiative and support the application submitted to the Federal Government to move forward with the fulfilment centre proposal.
