BEING A BY-LAW TO AMEND BY-LAW NO. 2431 WHICH ESTABLISHED A PLAN OF SICK LEAVE CREDIT GRATUITIES FOR EMPLOYEES OF THE CORPORATION OF THE CITY OF NORTH BAY AND ANY LOCAL BOARD (EXCEPT A SCHOOL BOARD) OR COMMISSION IN THE CITY OF NORTH BAY WHICH HAS NOT ESTABLISHED A PLAN OF SICK LEAVE CREDIT GRATUITIES FOR EMPLOYEES OR ANY CLASS THEREOF.

WHEREAS the Council of the Corporation of the City of North Bay desires to delegate to the Personnel Officer all duties that have been formerly assigned to the Treasurer in By-law No. 2431. NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

 In Sections 1(f), 2, 3 (a), 3 (b), 3 (c), 7 and 8 the word Treasurer shall now read Personnel Officer.

READ A FIRST TIME IN OPEN COUNCIL THIS 2nd DAY OF APRIL, , 1973. READ A SECOND TIME IN OPEN COUNCIL THIS 16th DAY OF APRIL , 1973. READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 16th DAY OF APRIL , 1973.

THE BOARD ORDERS that the corporation may incur an additional expenditure of \$105,000.00 for completion of the construction of parking garage approved by the previous order of the Board made on the 8th day of May, 1972 and entered in order book No. H 14 at folio 389 on the 12th day of July, 1972 and for such purpose may pass all requisite by-laws, including by-laws providing for the issue of debentures in a principal amount not exceeding \$73,000.00 repayable within the term prescribed in the said previous order, and may borrow money to the extent sufficient to provide an amount not exceeding \$73,000.00 therefor, provided:

1. that the corporation may borrow the whole or any part of the said sum of \$105,000.00 as required pending receipt of subsidies and the sale of debentures or the receipt of moneys from any other source,





- 2. that the amount to be debentured shall not exceed in any event the net cost to the corporation after deducting any grant or contribution from the Province of Ontario or from any other source in respect of the said work,
- 3. that the corporation in exercising any of its powers approved by this order shall comply with all statutory and other legal requirements related thereto.

AND THE BOARD ORDERS that the construction of a 3 storey parking garage is approved in place and stead of the 2 1/2 storey garage approved by the said previous order and such order is hereby amended accordingly.
