BEING A BY-LAW of the City of North Bay to establish a Recreation Committee for carrying on a community programme of recreation.

WHEREAS the Municipal Act 1954 being Chapter 56, Sec. 20, S.S.2, S.O. 1954, Provides for the carrying on of a programme of recreation within the meaning of the regulations under the Department of Education Act 1954 and for spending money or for granting money in aid for such purposes and for establishing the composition of and number to be appointed to Recreation Committee.

NOW THEREFORE THE COUNCIL OF THE COREORATION ENACTS AS FOLLOWS:-

- 1. That the Recreation Committee shall be composed of those seven members, at least two of whom shall be elected members of City Council, who are appointed annually to the Community Centres Management Board.
- That the Recreation Committee shall have no authority to hire or fire except with the approval of City Council, except casual labour.
- 3. That all funds expended on recreation must have the approval of City Council, and budget appropriations once approved by City Council may not be transferred from one budget account to another budget account without the consent and approval of City Council.
- 4. That all fees, gifts or donations for recreationsl purposes shall become the property of the City of North Bay.
- 5. That the Recreation Committee shall annually and before March 1st of each year, submit to City Council their anticipated budget which shall show revenue and expenditures.
- 6. That all monies coming into the hands of City Council for recreational purposes shall be held by the Treasurer of the City of North Bay and paid out by him onlywith the approval of City Council.
- 7. That the Recreation Committee shall apply for all or any assistance from any government or other authority; such assistance in the form of monies paid shall be made payable only to the City of North Bay.
- 8. The Recreation Committee is authorized and empowered to print and publish any paper, periodical, book or leaflet it may deem desirable for the promotion of its objects and to advertise its affairs, activities and undertakings by any means it may be thought advisable to the limits of budget appropriation.
- 9. The Recreation Committee is authorized and empowered to do all such other lawful things as are incidental or conductive to the achievement of its objects in accordance with Municipal Authority granted by City Council.
- 10. Notwithstanding anything to the contrary hereinbefore contained, all by-laws, rules and regulations of the Recreation Committee shall be subject to the approval of the Council of the City of North Bay.
- 11. In carrying out the provisions of this by-law the Recreation Committee shall at all times be agent of the Municipal Corporation of the City of North Bay and while acting bona fide within the limits of the authority of this by-law, neither the Recreation Committee nor any member thereof shall incur

any liability by reason of anything done or left undone by the Recreation Committee, provided however, that nothing in this paragraph contained shall authorize or empower the Recreation Committee to incur any debt, liability or obligation for which the Municipal Corporation of the City of North Bay shall become liable without having previously obtained the consent of the Council of the Corporation of North Bay.

12. THAT this By-law shall come into force and effect on the day of the final passing.
