And Whereas climate change is currently jeopardizing the health and survival of many species and other natural environments worldwide, stressing local and international eco systems;

And Whereas climate change is currently harming human populations through rising sea levels and other extraordinary phenomena such as flooding, wildfires, extreme heat events, etc., stressing local and international communities;

And Whereas the Intergovernmental Panel on Climate Change (IPCC) most recent report has indicated a need for massive reduction in carbon emissions of about 45% from 2010 in the next 11 years, reaching net zero carbon emissions by 2050, to have a reasonable chance of keeping global warming to 1.5C and maintaining a climate compatible with human civilization;

And Whereas, to date, the effects of climate change have been more pronounced in Northern Ontario than the rest of Ontario;

And Whereas climate action and the transition to a low-carbon economy also represents a massive opportunity for economic stimulation and growing job opportunities;

And Whereas the City of North Bay Community Emergency Plan defines an emergency as "A situation or impending situation caused by forces of nature, accident or an intentional act that constitutes a danger of major proportions to life and property.";

Therefore be it resolved that City of North Bay officially declare a climate emergency for the purposes of naming, framing, and deepening our commitment to protecting our economy, our community, our province, our country and our world from climate change;

And further that Council direct staff to prepare a report, to be delivered by the end of calendar year 2019, outlining which steps the City is already taking both in terms of climate change mitigation, by reducing carbon emissions as a result of City operations, and climate change adaptation, by coping with impacts that have already occurred and will occur as a result of climate change;

And further that Council recognize climate change and reduction of carbon emissions as a strategic priority in all planning decisions and accompanying budget directions;

And further that a copy of this resolution be forwarded to the Prime Minister of Canada, the Honourable Anthony Rota (MP Nipissing-Timiskaming), Premier of Ontario, Minister of Environment & Climate Change, Minister of Finance, and the Association of Municipalities of Ontario (AMO).

And further that Council recognize climate change and reduction of carbon emissions as a strategic priority in all planning decisions and accompanying budget directions.

2. The following paragraphs be inserted:

And Whereas since 2013, the City of North Bay has been completing, following and updating an annual Energy Conservation and Demand Management Plan that sets targets with the end goal being to reduce greenhouse gas emissions;

And Whereas the City of North Bay currently recognizes and plans for impending climate change with our waste water and drinking water systems;

And Whereas the City of North Bay's Strategic Plan specifies that we are to "Protect, promote and enhance the environment in all aspects of the city's operations and plans" as well as "we will identify and pursue opportunities to invest in technology and work practices to reduce the city's energy consumption";

And Whereas since 2007, the City of North Bay has reduced greenhouse gas emissions by 2129 tonnes of C02e, representing a 9% reduction in total Green House Gas emissions for the City of North Bay;

Therefore be it resolved that the City of North Bay confirm its support for the importance of Climate Change initiatives and that this should continue to be part of the decision-making framework in planning decisions;

And Further that City Council discuss climate change initiatives/priorities during the 2020 budget deliberations.

Therefore Be It Resolved that City staff be directed to reach out to our MPP, the Ministry of Transportation and the Provincial Government via the Premier and the Minister of Transportation, in a respectful exploratory manner to see if there can be any reason, pathway, or exceptional circumstance that Highway 11 be added as part of the designated 400 series of highways as highway 411.

And Further that a copy of this Resolution and a request for support be sent to those who may also benefit from the designation, including neighbouring communities, the North Bay and District Chamber of Commerce, Tourism North Bay, The Downtown Improvement Area Board of Management, Administration of Canadore College and Nipissing University, the North Bay Real Estate Board, the local representative of the Canadian Federation of Independent Business, and any other groups our staff feel would be beneficial.

And Further that copies be sent to MP Anthony Rota, The Federation of Northern Ontario Municipalities and The Association of Municipalities of Ontario.
