## BY-LAW NO. 2004-116

## BEING A BY-LAW TO AUTHORIZE THE SALE OF LANDS TO ANTONIO SERVELLO (1000 Lakeshore Drive – Remainder of Parcel 3271 W&F)

WHEREAS an Agreement of Purchase and Sale with Antonio Servello for the sale of vacant city owned land was approved by Resolution No. 2004-398 passed on the 31st day of May, 2004, after an open, competitive process;

AND WHEREAS the Municipality is authorized by Section 268 of the *Municipal Act*, 2001, to dispose of lands no longer required for municipal purposes;

AND WHEREAS the lands herein were declared surplus by Resolution No. 2004-108 which was passed by Council at its Regular Meeting held on Monday, February 9, 2004;

AND WHEREAS the notice of sale of this City owned land was advertised for two consecutive weeks in the North Bay Nugget on April 13, 2004 and April 24, 2004;

AND WHEREAS an appraisal of the lands was completed in March 2004;

AND WHEREAS Council deems it desirable to convey the Remainder of Parcel 3271 Widdifield and Ferris to Antonio Servello.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- That The Corporation of the City of North Bay enter into an agreement with Antonio Servello dated the 3<sup>rd</sup> day May, 2004 relating to the sale of vacant city owned land described as the Remainder of Parcel 3271 Widdifield and Ferris, City of North Bay, District of Nipissing.
- The Corporation of the City of North Bay is hereby authorized and directed to transfer the Remainder of Parcel 3271 Widdifield and Ferris, City of North Bay, District of Nipissing to Antonio Servello.
- 3. The Mayor, and the Clerk of The Corporation of the City of North Bay are hereby authorized to execute that certain agreement between The Corporation of the City of North Bay Antonio Servello and to affix thereto the corporate seal, and the City Solicitor is hereby authorized to execute such further and other documents as may be reasonably required to complete the transaction.
