## THE CORPORATION OF THE CITY OF NORTH BAY

## BY-LAW NO. 2002-74

BEING A BY-LAW TO ANNEX CERTAIN LANDS FROM THE UNINCORPORATED TOWNSHIP OF COMMANDA (North Bay Regional Health Centre)

**WHEREAS** the North Bay Regional Health Centre has applied to The Corporation of the City of North Bay to annex certain lands in the adjacent unincorporated Township of Commanda in order to bring all the lands owned by the North Bay Regional Health Centre within one municipal jurisdiction of The Corporation of the City of North Bay;

**AND WHEREAS** the name "North Bay Regional Health Centre" is a name to identify the location of the new joint hospitals with the two legal entities being North Bay General Hospital and Northeast Mental Health Centre;

**AND WHEREAS** the lands forming the subject matter of the annexation are currently owned by Nipissing University and the Board of Governors of the Canadore College, subject to an Agreement of Purchase and Sale for the North Bay Regional Health Centre to acquire the lands:

**AND WHEREAS** Nipissing University and the Board of Governors of the Canadore College own all of the lands abutting the subject lands;

**AND WHEREAS** the subject lands are vacant and unoccupied and the Township is not incorporated or otherwise organized;

**AND WHEREAS** the Council of The Corporation of the City of North Bay has agreed to accommodate this request by Resolution No. 2002-94 dated February 25,2002;

**AND WHEREAS** this By-law is presented for the purpose of approving the annexation, subject to public notice and a hearing by the Ontario Municipal Board;

**AND WHEREAS** the Ontario Municipal Board has approved this annexation by Order dated the 19<sup>th</sup> day of December, 2002 and entered on the 20<sup>th</sup> day of December, 2002.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. Those certain lands described herein are hereby annexed to and shall form part of the City of North Bay: being Part of Lot 1, Concession "B", designated as Parts 16 to 25 (inclusive), Plan 36R-10957, in the Unincorporated Township of Commanda, in the District of Nipissing.
- 2. Notice of this by-law shall be given as directed by the Ontario Municipal Board by the City Clerk.
- 3. This by-law comes into effect upon the approval of the Ontario Municipal Board.

READ A SECOND TIME IN OPEN COUNCIL THE 8<sup>TH</sup> DAY OF JULY, 2002.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 13<sup>th</sup> DAY OF JANUARY, 2003.
