

BY-LAW NO. 2036

BEING A BY-LAW of the Corporation of the City of North Bay to authorize the construction of an addition and certain alterations to the Algonquin Composite School by the North Bay Collegiate Institute and Vocational School Board.

WHEREAS it is expedient to make certain alterations and to construct and equip an addition to the Algonquin Composite School consisting of three (3) classrooms, two (2) drafting rooms, one (1) electrical shop, one (1) welding shop, one (1) auto mechanic shop, one (1) occupational training area for boys, one (1) occupational training area for girls, one (1) cafeteria and one (1) transformer vault.

AND WHEREAS it is expedient to borrow for alterations and for the construction and equipping of the said addition to the Algonquin Composite School the sum of \$195,000.00.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT the North Bay Collegiate Institute and Vocational School Board be given authority to make alterations and to construct and equip such new addition of three (3) classrooms, two (2) drafting rooms, one (1) electrical shop, one (1) welding shop, one (1) auto mechanic shop, one (1) occupational training area for boys, one (1) occupational training area for girls, one (1) cafeteria and one (1) transformer vault, to the Algonquin Composite School subject to approval by the North Bay City Council by resolution.
2. THAT the North Bay Collegiate Institute and Vocational School Board shall forthwith make such plans and specifications as may be necessary for the calling of tenders, and for the making of a contract for the execution of the work.
3. THAT the work shall be carried on and executed under the supervision and according to the direction of the North Bay Collegiate Institute and Vocational School Board, or its architect.
4. THAT the Treasurer of the City of North Bay may, subject to the approval of the Council, agree with any Bank or person for temporary advances of money to meet the cost of construction pending the completion of such construction.
5. THAT the debentures to be issued for the loan to be effected to pay for the cost of this work, shall bear interest at such rate as the Council may determine and the debenture principal and the debenture interest be made payable within twenty years on the instalment plan as approved by the Department of Education, and under authority of the Secondary Schools and Boards of Education Act, being Chapter 362, Section 31, R.S.O. 1960.
6. THAT this By-law shall only become effective on the final passing after approval in writing has been secured from The Ontario Municipal Board by virtue of Section 64, Ontario Municipal Board Act, Chapter 274, R.S.O. 1960.

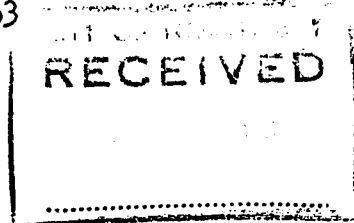

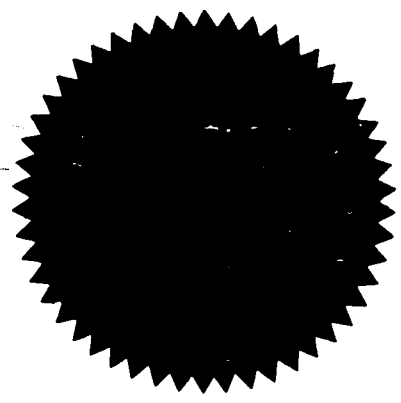
