BY-LAW NO. 2008-155

**BEING A BY-LAW TO AMEND TRAFFIC & PARKING
BY-LAW NO. 2002-01, AS AMENDED**

WHEREAS the Council passed Resolution No. 2008-392 at its Regular Meeting held Monday, May 26, 2008 to establish parking meter zones, two-hour parking zones, clarify operational parameters of parking and loading zones, and amend the definition of "Park" or "Parking";

AND WHEREAS the Council passed Resolution No. 2008-398 at its Regular Meeting held Monday, May 26, 2008 to include parking restrictions on Fisher Street from Main Street to the Highway.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Section 1 of By-law No. 2002-01 is amended to delete the following:

"(u) "Park" or "Parking" means the standing of a vehicle whether occupied or not, except when standing for the purpose of and while actually engaged in loading or unloading."

And insert the following in lieu thereof:

"(u) "Park" or "Parking" means the stopping or standing of a vehicle whether occupied or not, with or without the engine activated."

2. Paragraph (2) of Section 9 (No U-Turns – Schedule 4) of By-law No. 2002-01 is hereby deleted.

3. **Schedule 11** (School Bus Loading Zone – Section 17) of By-law No. 2002-01 is amended to delete the following:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
Second Avenue	north	From a point 65 metres north of Cassells Street northerly for a distance of 15 metres.

And insert the following in lieu thereof:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
Second Avenue	north	From a point 38 metres west of Commercial Street to a point 61 metres west of Commercial Street.

4. **Schedule 12** (Loading Zones – Section 18) of By-law No. 2002-01 is amended to delete the following:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
McIntyre Street	north	64 metres west of Ferguson Street and 72 metres west of Ferguson Street.

And insert the following in lieu thereof:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
McIntyre Street	north	64 metres west of Ferguson Street and 80 metres west of Ferguson Street.

5. **Schedule 18** (No Parking Areas At Any Time – Section 28) of By-law No. 2002-01 is amended to delete the following:

Oak	south	Fraser and Cassells	\$1.25

And insert the following in lieu thereof:

10. **Schedule 22** (Parking Meter Zones – Section 31) of By-law No. 2002-01 is amended to include the following:

Zone # 2 - Four hour maximum parking time limit
