THE CORPORATION OF THE CITY OF NORTH BAY BY-LAW NO. 2209

Being a by-law closing for vehicular traffic only and not for pedestrian traffic the whole of that part of Rock Street lying between and immediately adjoining Lots 108 and 109 as shown on Registered Plan No. 15 for the City of North Bay registered in the Registry Office for the District of Nipissing and to provide for the erection of barricades to enforce the due observance thereof.

WHEREAS that part of Rock Street, hereinafter more particularly described, is situate in the centre of the "Kinette Playground" and has been and still is being used for playground purposes.

AND WHEREAS for the safety and protection of the children using the said playground it is necessary and advisable to close for vehicular traffic only and not for pedestrian traffic that part of Rock Street, hereinafter more particularly described, and to provide for the erection of barricades to enforce the due observance thereof.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. For the purposes hereinbefore recited and pursuant to The Municipal Act, R.S.O. 1960, Chapter 249, Section 459(7) the whole of that part of Rock Street in the City of North Bay, as hereinafter more particularly described, is hereby closed for vehicular traffic only and not for pedestrian traffic.
- 2. That barricades be erected to enforce the due observance of this by-law.
- 3. The following is a description of that part of Rock Street being closed for vehicular traffic only:

Commencing at the south-westerly angle of Lot 108 as shown on Registered Flan No. 15 for the City of North Bay registered in the Registry Office for the District of Nipissing; thence northerly along the westerly limit of the said lot to the north-westerly angle of the said lot; thence westerly along the production of the northerly limit of Lot 108 afcresaid to the north-easterly angle of Lot 109 as shown on the said Plan; thence southerly along the easterly limit of said lot 109 to the south-easterly angle of said Lot 109; thence easterly along the production of the southerly limit of Lot 109 to the point of commencement.

h. This by-law shall come into full force and effect upon due compliance with the applicable provisions of Section 46.2(1) of The funicipal Act aforesaid and upon the final passing of this by-law.
