apply to the Registered Plan and Lots described
as follows:

Lot No. 1 (one) to Lot No. 45 (forty-five)
inclusive, Registered Plan M-458

READ A SECOND TIME IN OPEN COUNCIL THIS 10th DAY OF September, 1973.

THE BOARD ORDERS that The Corporation of the City of North Bay may amend the sewage rate by-law passed pursuant to the previous order of the Board made herein on the 15th day of

July, 1971, and entered in order book No. H 8 at folio 174 on the 1st day of September, 1971 by providing for reduction of the sewage rate referred to in Schedule "A" to such previous order under certain circumstances as follows:

"Where water is supplied by The Corporation
"of the City of North Bay to lands that are
"used for commercial or industrial purposes
"and such water is not discharged, deposited
"or emitted back into the sewage system, a
"reduction of the sewage rate be made thereon
"sufficient having regard to the situation
"to adjust the surcharge to compensate for
"the rate charged to the municipality
"pursuant to the said agreement."

and such schedule shall be amended accordingly.

AND THE BOARD ORDERS that its said previous order shall be further amended by providing that the sewage rate referred in Schedule "A" thereto shall be subject to the exemptions set out in By-law 13-71 as amended by By-law 90-73.
