## BY\_LAW NO. 1928

APP 51 ( 963

BEING A BY-LAW to establish Community Centres and a Board for the management thereof, within the City of North Bay.

WHEREAS this Council deems it expedient to provide for the establishment of certain community centres in accordance with the provisions of The Community Centres Act R.S.O. 1950, Chapter 58 and amendments thereto;

AND WHEREAS the said Act provides that every community centre so established shall be under the management and control of a Board appointed by the Council of the Municipality;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That the following community centres be and the same are hereby established, namely:

Canadian Legion Community Centre Elks Community Centre Kinette Community Centre Kiwanis Community Centre Kings Castle Community Centre Kinsmen Beach Community Centre Lee Park Athletic Field Amelia Park Athletic Field

- 2. Each and every of the said community centres and all other community centres which may hereafter be established under the provisions of the said Act, shall be under the management and control of a Board appointed by the Municipal Council of the City of North Bay, which shall be known as the Community Centres Management Board and which shall be composed of two members of City Council and five members selected by Council from among the officers of the local organizations who use the community centres established under this by-law and any amendment hereof.
- 3. In selecting the representatives of such organizations who shall serve on the Community Centres Management Board, Council shall have regard to the contribution by each organization to the erection and maintenance of the said community centres.
- 4. Any vacancy arising on the Community Centres Managemet Board, may be filled by Council from among the class of representatives in which the vacancy occurs.
- 5. The representatives of the Council shall be appointed annually and shall hold office until their successors are appointed, and every other member of the Board shall hold office for two years from the date of his appointment and until his successor is appointed.
- 6. The Community Centres Management Board may make such rules as it deems necessary relating to the management and control of the said community centres and may fix such charges for the use of same as it deems advisable.
- 7. Any local organization, society or other body by which any community centre established under this Act may be used under the regulations, may make grants out of any monies in their hands in aid of the erection and/or maintenance of a community centre established hereunder.
- 8. No community centre established hereunder shall be sold or disposed of within twenty years from the time aid was last granted to such community centre out of monies appropriated therefor by the Legislature, without the approval of the Minister.

- 9. All banking records and books of account pertaining to the building, maintenance, and operation of every community centre established hereunder, shall be under the jurisdiction of the City Treasurer, and the signing authorities shall be the same as the signing authorities for the City of North Bay.
- 10. The said Board shall submit to Council on or before the 1st day of March in each and every year, an estimate of revenue and expenditures on account of each of the said Community Centres for the current year and after being duly approved by Council such estimates shall not be over-expended without prior approval by Resolution of the Council.
- 11. The said Board of Management shall forward to Council a monthly statement of revenue and expenditures.
- 12. The said Board of Management: shall:
  - (a) Appoint a Chairman, Vice-Chairman and Secretary from among its members;
  - (b) Appoint the time and place of its meetings;
  - (c) Make regulations respecting the proceedings and procedure at its meetings;
  - (d) Keep proper and correct minutes of all of its meetings;
  - (e) Deliver to Council immediately following every meeting, a copy of the Minutes of such meeting;
  - (f) Report fully and punctually to Council on any other business conducted by the said Board, upon being requested so to do by Council.
