

Your Worship and Councillors:

The General Government Committee presents Report No. 2019-04 and recommends:

- That 1) in accordance with Provincial Legislation and the City's Sustainable Financial Plan for Water and Wastewater Systems approved by Council, the current policy of recovering all Water and Wastewater operating, capital and financial costs from user rates be maintained;
 - the Water and Wastewater Calculated Rates, as per amended Appendix "A", be approved by Council effective January 1st, 2019, and that a by-law be presented to Council for three (3) readings on January 30th, 2019; and
 - Council continue to support the residential low-flow toilet replacement rebate program, and maintain the per account limit at two (2) toilets until such time as the \$100,000 initial program funding is spent.
