

BY-LAW NO. 1749

BEING A BY-LAW of the Municipal Corporation of the City of North Bay to close a portion of a lane, said portion lane being composed of a lane running northerly from Lorne Avenue to the northerly limit of the City of North Bay and lying at the rear of the lots facing on O'Brien Street and at the rear of the Lots facing on McPhail Street according to a plan of subdivision entered in the Office of Land Titles for the said district as Plan M.28.

WHEREAS The municipal Council of the Corporation of the City of North Bay have been requested, and upon consideration deem it advisable to close a portion of a lane in the City of North Bay, said portion of lane being composed of a lane running northerly from Lorne Avenue to the northerly limit of the City of North Bay and lying at the rear of the lots facing on O'Brien Street and at the rear of the lots facing on McPhail Street according to a plan of subdivision entered in the office of Land Titles for the said district as Plan M.28.

THEREFORE under and by virtue of the authority vested in the Council of the Municipal Corporation of the City of North Bay by the Municipal Act, being R.S.O. 1950, Chapter 243, THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. THAT a portion of a Lane in the City of North Bay being composed of a portion of a lane from Lorne Avenue northerly to the City limits and located midway between McPhail and O'Brien Streets as shown on a Plan M.28 filed in the Office of Land Titles of the District of Nipissing and which said part of the said lane may be more particularly described as follows:

Commencing at the southeast angle of Lot 401 of the said plan; thence northerly along the easterly limits of Lots 401, 402, 403, 404, 405, 406 and 407, a distance of 358 feet 3 inches to the north east angle of said lot 407; thence easterly in a straight line 14 feet to the north west angle of Lot 408 of the said Plan; thence southerly along the westerly limits of said lot 408, Lots 409, 410, 411, 412, 413 and 414 a distance of 358 feet 4 inches to the south west angle of said lot 414; thence westerly in a straight line, 14 feet more or less to the said point of commencement, IS HEREBY CLOSED AND STOPPED UP.

- 2. THAT forthwith upon this By-Law taking effect the Council of the Municipal Corporation of the City of North Bay shall convey the said portion of lane as closed and stopped up in the next preceding section to the registered owners of the lands abutting thereon for the consideration of the sume of One Dollar (\$1.00)
- 3. THAT the Council of the Municipal Corporation in the City of North Bay shall hear in person or by his or her solicitor, counsel or agent, any person who claims that his or her lands will be prejudicially affected by this By-Law and who applies to be heard.
- 4. THAT this By-Law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.
