THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 33-97

BEING A BY-LAW TO AUTHORIZE AN APPLICATION TO THE ONTARIO MUNICIPAL BOARD TO AMEND THE SERVICES INCLUDED IN THE URBAN SERVICE AREA

WHEREAS the Municipal Council of the City of North Bay considers it expedient to amend its Urban Service Area by adding certain urban services thereto and to apply for an Order of the Ontario Municipal Board to do so and, in all the circumstances, to dispense with a public hearing therefore.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

By-law 68-71 is hereby amended to read as follows:

- 1. That the proper officers of the Municipal Corporation of the City of North Bay are hereby authorized and directed to apply to the Ontario Municipal Board for an Order pursuant to the provisions of Section 15, Subsection 1 of the *Municipal Act*, being Chapter M-45, of the Revised Statutes of Ontario, 1990, as amended to date, amending the services charged against the area described in Schedule "A" attached to By-law No. 68-71, as amended, and outlined in the plan attached as Schedule "B" to By-law No. 68-71, as amended, being an Urban Service Area and providing as follows:
- (a) That mill rates may be levied annually on the Urban Service Area in an amount sufficient to recover:
 - (i) any capital cost of the water supply system not recovered through the collection of water rates on the water bill.
 - (ii) any capital cost of the sanitary sewer system not recovered through the collection of sewer rates on the water bill.
 - (iii) the capital and maintenance cost of storm sewers in the storm drainage area.
 - (iv) the capital, operating and maintenance costs of providing street lighting.
 - (v) the capital, administrative and maintenance costs of providing flood and erosion control.

- (vi) the operating and maintenance costs of snow removal.
- (vii) the maintenance costs of providing sidewalks including winter maintenance.
- (viii) the operating and maintenance costs of traffic control.
- (ix) the administration and overhead costs associated with items (i) to (viii).
- 3. This by-law shall come into force as of the date of approval by the Ontario Municipal Board and be applied as of January 1, 1997.
