

BY-LAW NO. 1797

BEING A BY-LAW of the Municipal Corporation of the City of North Bay to provide for final cost of completion of the Community Memorial Building and adjacent Grounds and Streets.

WHEREAS by By-Laws No. 1700 and No. 1737 the qualified electors of the Corporation of the City of North Bay did approve of an expenditure of \$635,000.00 for the construction of the Community Memorial Building.

AND WHEREAS by By-Laws No. 1711 and No. 1741 and No. 1774 authorized the construction of the Community Building to \$714,540.00.

AND WHEREAS the Municipal Corporation of the City of North Bay deem it advisable to provide an additional \$4,460.00 for to meet the final cost of completion and equipping of the Community Memorial Building and the improvement of lands, street and parking area adjacent thereto.

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT the Municipal Corporation of the City of North Bay proceed with the completion and equipping of the Community Memorial Building and the improvement of Lands, Streets and Parking Area adjacent thereto.
2. THAT for the purpose aforesaid there shall be borrowed on the credit of the Corporation at large, the sum of Four Thousand, Four Hundred and Sixty Dollars.
3. THAT the debentures to be issued for the loan to be effected to pay such final cost of the work when completed shall bear interest at such rate as this Council may determine and be made payable in 20 years on the instalment plan.

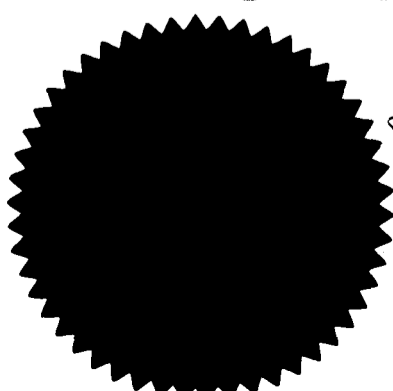
