

BEING a By-Law to authorize construction of a sanitary sewer, storm sewer and watermains and private sewer and water connections on Douglas Street, Morin Street, McLeod Street, Lorne Avenue and McPhail Street.

WHEREAS the owners of property abutting on the streets above mentioned and which area is more particularly referred to and identified, as the Integrated Housing Project, have petitioned the Council to construct a sanitary sewer, a storm sewer and a watermain with all necessary private house connections said petition being dated, the 18th day of August, 1948.

THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. That a four inch watermain and a nine inch sanitary sewer be constructed on Douglas Street from the City Limits in a southerly direction to Lot 81, a distance of 522 lineal feet more or less.
2. That a four inch watermain and a nine inch sanitary sewer be constructed on Morin Street from the City Limits in a southerly direction to Lot 101, a distance of 473 lineal feet more or less.
3. That a four inch watermain and an eight inch sanitary sewer be constructed on McLeod Street from the City Limits in a southerly direction to Rose Avenue, a distance of 900 feet more or less.
4. That a six inch watermain and a ten inch sanitary sewer be constructed on Lorne Avenue from Douglas Street in an easterly direction to McLeod, a distance of 660 feet more or less.
5. That a six inch watermain and a twelve inch sanitary sewer be constructed on Lorne Avenue from McLeod Street in an easterly direction to O'Brien Street, a distance of 660 feet more or less.
6. That a twelve inch sanitary sewer be constructed on McPhail Street from Rose Avenue in a southerly direction to High Street, a distance of 566 feet more or less.
7. That a storm sewer, twelve inches in diameter be constructed on Lorne Avenue from Douglas Street in an easterly direction to Morin Street, a distance of 346 Feet more or less.
8. That a storm sewer, fifteen inches in diameter be constructed on Lorne Avenue in an easterly direction to McLeod Street, a distance of 346 feet more or less.
9. That sewer connections to private property be installed to the property line for all those property owners who desire and apply to the City Engineer to have such connections provided.
10. That water service connections to private property be installed to the property line for all those property owners who desire and apply and pay the necessary charges as prescribed by By-Law.
11. That the engineer of the Corporation do forthwith make such plans, profiles and specifications and furnish such information as may be necessary for the making of a contract for the execution of the work.
12. That the work shall be carried on and executed under the superintendence and according to the directions of such Engineer.
13. That Mayor and Clerk of the Corporation are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council which may be declared by Resolution.

- 14. That the Treasurer may, subject to the approval of the Council, agree with any Bank or person for temporary advances of money to meet the cost of construction pending the completion of it.
- 15. That the cost of all sanitary and storm sewer installations be borne entirely by the property owners of Douglas Street, Morin Street and McLeod Street, west side only, whose property is abutting on the work as a Local Improvement over a period of 15 years.
- 16. That the cost of all watermain construction be paid for out of Current Revenues of the Waterworks Department.
- 17. That the cost of sewer connections to private properties be paid for as a local improvement by the property owners concerned over a period of 15 years on the basis of actual cost of such private sewer installation.
- 18. That all previous By-Law in whole or in part as they may affect this By-Law are hereby suspended.
