BY-LAW NO. 1938

BEING A BY-LAW of the Corporation of the City of North Bay to provide for the submission of a certain question for the assent of the electors, and to appoint a day on which to take a vote thereon, and to name the places where votes are to be taken, and to appoint Deputy Returning Officers to take the vote at each such place.

WHEREAS the said Council deems it advisable to submit to the vote of the electors of the Corporation the following question:-

WHEREAS the Lord's Day (Ontario) Act provide that the Council of a Corporation may submit to the electors of the Corporation the hereinafter mentioned question whether they are in favour of public games and sports on the Lord's Day to be regulated by a Municipal By-law under the authority of the Lord's Day (Ontario) Act.

AND WHEREAS the said Council desires to submit the said question to the electors

NOW THEREFORE THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT there shall be submitted to the electors of the City of North Bay the following question:

"Are you in favour of public games and sports on the Lord's Day to be regulated by Municipal By-law under the authority of the Lord's Day (Ontario) Act?"

2. THAT the vote of the said electors shall be taken on the said question at the same time and places and by the same Deputy Returning Officers and Poll Clerks, as the Municipal Election.

3. THAT a true copy of the question shall be published in the North Bay Daily Nugget on the days hereinafter mentioned, that is to say on the Ninth, Sixteenth and Twenty-third days of November, 1960.

4. THAT on the Thirtieth day of November, at his office in the Council Chambers on McIntyre Street at the hour of 2.00 o'clock in the afternoon, the Mayor will, in writing, signed by him, appoint two persons to attend the final summing up of the votes by the Clerk of the Corporation, and one person to attend each Polling Place on behalf of the persons interested in and desirous of promoting the acceptance of the said question, and a like number on behalf of the persons interested in and desirous of the rejection of the said question.

5. THAT the fourteenth day of December at the said Council Chambers at 12 o'clock noon is hereby appointed as the time and place for summing up by the Clerk of the Corporation of the number of votes given in the affirmative and in the negative, respectively.
