By-Law No. 2021-19

**Being a By-Law to Authorize the Renaming
of Airport Way to Bob Wood Drive**

WHEREAS section 1.(1) *Municipal Act*, S.O. 2001, c. 25, (the "Act"), as amended defines "highway" as a common and public highway and includes any bridge, trestle, viaduct or other structure forming part of the highway and except as otherwise provided, includes a portion of a highway;

AND WHEREAS section 5(1) of the Act, provides that the powers of a municipal corporation shall be exercised by Council;

AND WHEREAS section 5 (3) of the Act provides a municipal power, including a municipality's capacity, rights, powers and privileges under section 9 of the Act, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise and any of the matters shall be implemented by the exercise of the natural person powers;

AND WHEREAS section 27.(1) of the Act provides that except as otherwise provided in this Act, a Municipality may pass by-laws in respect of a highway only if it has jurisdiction over the highway;

AND WHEREAS the Jack Garland Airport Board has approved the renaming of "Airport Way", the main entrance roadway to the airport to "Bob Wood Drive";

AND WHEREAS at its Regular Meeting held on Tuesday, December 8, 2020, Council passed Resolution No. 2020-392 approving the renaming of Airport Way to Bob Wood Drive;

AND WHEREAS notice of the passing of this By-Law was given in accordance with By-Law 2020-79 being a By-Law to Establish a Notice Policy;

AND WHEREAS no person has claimed that his or her lands will be prejudicially affected by the passing of this by-law nor applied to be heard in person or by his or her counsel, solicitor or agency by the Council of the said City or a Committee of said Council.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. The existing name of "Airport Way" is hereby changed to "Bob Wood Drive" as shown on Schedule "A" hereto.
2. The new road name shall be affixed to sign posts located at the corners of such streets of the previous name signs.
3. This By-Law comes into force and effect upon a certified copy of the by-law being registered in the Land Titles Office for the District of Nipissing.

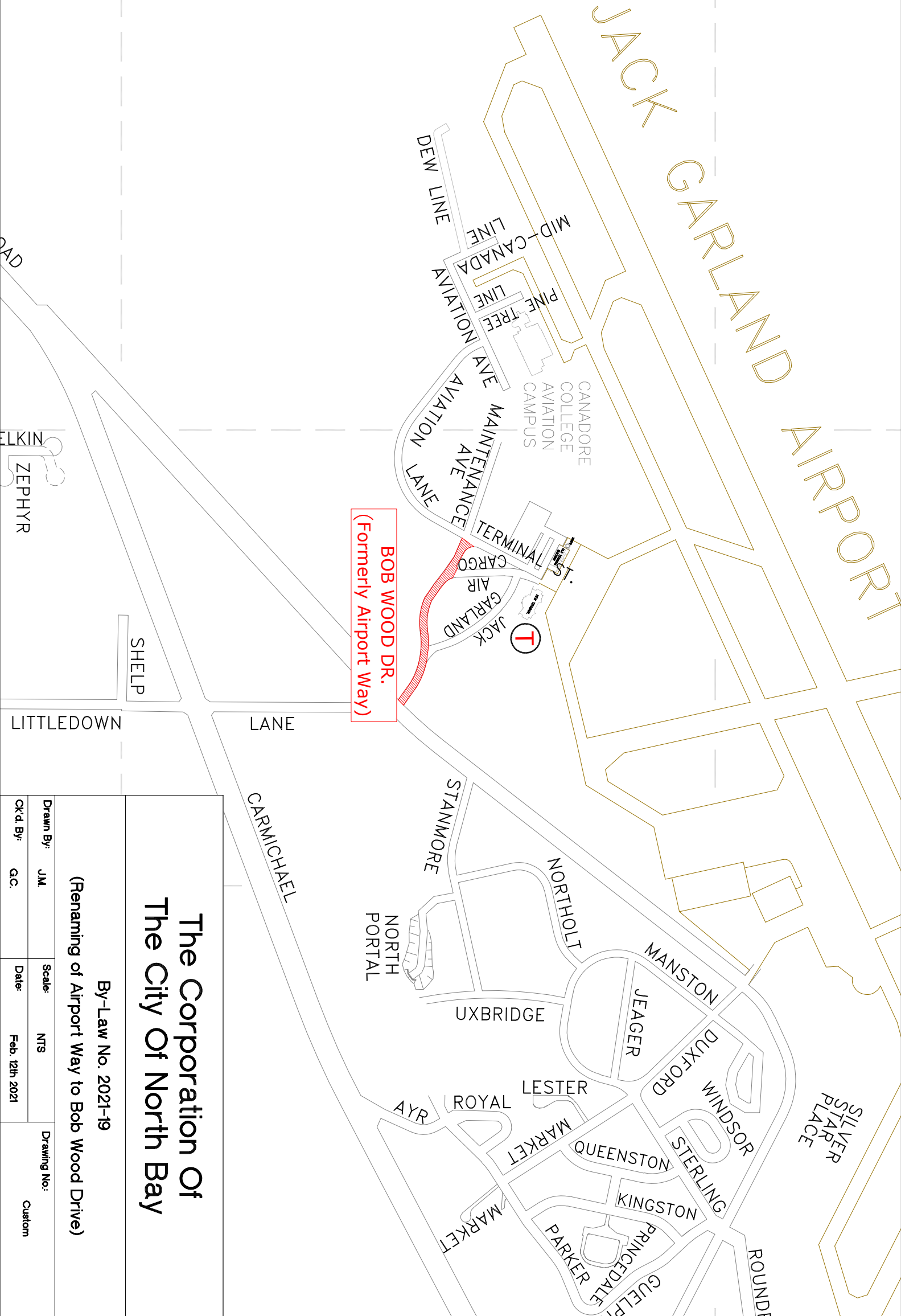
