THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 40770

BEING A BY-LAW TO APPOINT A LOTTERY LICENSING OFFICER AND TO PROVIDE FOR A PROCEDURE AND OTHER REQUIREMENTS IN RESPECT OF THE LICENSING OF LOTTERIES FOR CHARITABLE AND RELIGIOUS PURPOSES.

WHEREAS The Municipal Act of the Province of Ontario provides that councils of all municipalities may pass by-laws appointing such officers and servants as may be necessary for the purpose of the corporations;

AND WHEREAS it is deemed expedient to appoint a Lottery Licensing Officer, and to establish certain procedures and requirements in respect of the granting of lottery licences for charitable and religious purposes;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. John M. Montemurro is hereby appointed Lottery Licensing Officer for the City of North Bay.
2. The said John M. Montemurro shall hold office during the pleasure of the Council of the said Corporation and shall exercise all the authority, powers and rights and shall perform all the duties and obligations which by Order-in-Council, statute, or by-law are or may be conferred or imposed upon him as Lottery Licensing Officer, and any other duties that may be designated by the Council of the said Corporation; and without limiting the generality of the foregoing, the Licensing Officer shall adhere to and apply all requirements in respect of the licensing of lotteries set out in Order-in-Council 274/70 of the Province of Ontario and all amendments thereto, the "Terms and Conditions Under Which The Lottery Licence is Issued" as established by the Department of Financial and Commercial Affairs of the Province of Ontario, and all amendments to such "Terms and Conditions".
3. All applications for licences pursuant to this by-law shall be on forms prescribed or adopted by the Council of the said Corporation and shall be supported by Certificates so prescribed or adopted.
4. The Council of the Corporation may suspend or cancel any licence for the breach of any term or condition upon which it was granted.
5. The Corporation shall issue licences to applicants for permission to manage and conduct lotteries pursuant to this by-law, in accordance with the following schedule of fees:
  1. Bingo Lotteries:
    - (a) Where the total value of prizes to be awarded within each operation does not exceed \$500.00 - \$5.00 per licence; provided that where such total value does not exceed \$25.00, a fee of \$2.00 shall be charged.
    - (b) Where the total value of prizes to be awarded within each operation exceeds \$500.00 but is not more than \$3,500.00 - a fee of 2% of the total value or prizes as set out in the application.

(c) A license for a series of bingo lotteries shall be issued on the same basis as (a) or (b) above.

2. Raffle Lotteries:- An amount equal to 2% of the estimated total value of prizes to be awarded shall be applied.

3. Bazaars: - \$5.00

All applications for the licensing of lotteries in excess of the monetary limits set out herein shall, subject to prior approval and recommendation of the Council of the Corporation, be referred to the Department of Financial and Commercial Affairs of the Province of Ontario.
