

BY-LAW NUMBER 773.

BEING A BY-LAW to authorize the construction of Bridges on certain Streets over Chippewa Creek in the Town of North Bay as set out in Schedule "A" hereto attached and which forms part of this By-Law as a Local Improvement under the Provisions of the Local Improvement Act.

WHEREAS it is expedient that the construction of the work hereinafter described, shall be undertaken as a Local Improvement, and notice of the intention of the Council to undertake such work has been duly published.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF NORTH BAY ENACTS AS FOLLOWS :-

THAT it is determined and declared, this By-Law being passed by a vote of two-thirds of all the members of the Council, it is desirable that the construction of certain bridges over Chippewa Creek in the Town of North Bay, as set out in Schedule "A" hereto attached, and which forms part of this By-Law, should be undertaken as a Local Improvement under the provisions of the Local Improvement Act.

THAT as above determined and declared the said bridges be constructed as set out in Schedule "A" above referred to, as a Local Improvement under the Provisions of the Local Improvement Act.

THAT the Engineer of the Corporation do forthwith make such plans, profiles and specifications and furnish such information as may be necessary for the making of a Contract for the execution of the work.

The work shall be carried on and executed under the superintendence and according to the directions of such Engineer.

The Mayor and Clerk are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to the approval of this Council, to be declared by Resolution.

The Treasurer, may subject to the approval of the Council agree with any Bank or person for temporary advances of money to meet the cost of the work, pending the completion of it.

The Special Assessment shall be paid by 20 equal annual instalments.

The Debentures to be issued for the Loan, to be effected to pay for the cost of the work when completed shall bear interest at 5½% per cent per annum, and shall be payable within 20 years, on the Instalment plan.

Any person whose lot is specially assessed may commute for a payment in cash the special rates imposed thereon, by paying the portion of the cost of construction assessed upon such lot without the interest, forthwith after the Special Assessment Roll has been certified by the Clerk.

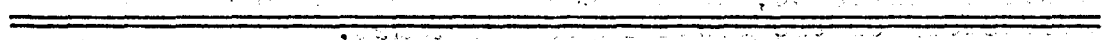

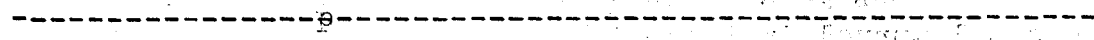
