BY-LAW NO. 2007-182

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT DATED THE 20TH DAY OF AUGUST, 2007 WITH HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF ONTARIO, REPRESENTED BY THE MINISTER OF TRANSPORTATION FOR THE PROVINCE OF ONTARIO RELATING TO THE JOINT PROCUREMENT OF TRANSIT BUSES

WHEREAS the agreement with Her Majesty the Queen in right of the Province of Ontario, represented by the Minister of Transportation for the Province of Ontario, The Corporation of the City of Barrie, The Corporation of the City of Burlington, The Regional Municipality of Durham, London Transit Commission, Windsor Transit, The Regional Municipality of York and The Corporation of the City of North Bay for the joint procurement of Transit Buses was approved by Resolution No. 2007-536 passed on the 7th day of August, 2007;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- That The Corporation of the City of North Bay enter into an agreement with Her Majesty the Queen in right of the Province of Ontario, represented by the Minister of Transportation for the Province of Ontario, The Corporation of the City of Barrie, The Corporation of the City of Burlington, The Regional Municipality of Durham, London Transit Commission, Windsor Transit and The Regional Municipality of York dated the 20th day of August, 2007 relating to the joint procurement of transit buses.
- 2. That the Mayor and Clerk of The Corporation of the City of North Bay are hereby authorized to execute that certain agreement between The Corporation of the City of North Bay and Her Majesty the Queen in right of the Province of Ontario, represented by the Minister of Transportation for the Province of Ontario, The Corporation of the City of Barrie, The Corporation of the City of Burlington, The Regional Municipality of Durham, London Transit Commission, Windsor Transit and The Regional Municipality of York and to affix thereto the corporate seal.

READ A SECOND TIME IN OPEN COUNCIL THE 20TH DAY OF AUGUST, 2007.
