Moved by Councillor Mayne, seconded by Councillor Campbell WHEREAS the Federation of Canadian Municipalities encourages reduced plastic bottled water at Municipal facilities and encourages the use of tap water over bottled water where appropriate and so passed a motion at their National Meeting in Victoria, March 7, 2009;

AND WHEREAS bottled water containers may be recyclable but they still have to be manufactured and transported, which uses significant energy, and that between 40 and 80 per cent end up in the local landfill which is a burden on the environment and a cost for municipal taxpayers;

AND WHEREAS the City of North Bay has been working to reduce its use of disposable plastic water bottles and increase its use of North Bay tap water and reusable containers;

AND WHEREAS North Bay provides excellent municipal drinking water;

AND WHEREAS the City of North Bay has an opportunity to be a part of a community awareness poster campaign to promote the use of local water and reduced use of disposable plastic bottles;

THEREFORE BE IT RESOLVED THAT the City of North Bay support the North Bay Blue Bottle Poster Campaign and continue to promote the use of North Bay tap water and reusable drinking containers whenever practical, and that the North Bay Blue Bottle posters be displayed at all Municipal facilities as appropriate.

AND WHEREAS provincial funding to Ontario's Conservation Authorities has decreased by 47% since 1992 – (MNR funding transfer to Conservation Authorities – 1992 = \$58,900,000 - 2008 = \$27,400,000);

AND WHEREAS due to the shortfall in provincial funding, member municipalities now are required to fund approximately 40% of the Ontario Conservation Authorities budgets;

AND WHEREAS this results in an unfair per capita cost burden on property owners;

THEREFORE BE IT RESOLVED THAT the City of North Bay request the following action:

 That Conservation Ontario implement and prioritize a major lobby effort directed at the Provincial Government and MNR to demand fair funding in program areas of provincial interest; 2.
