WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to amend By-law No. 1896 of The Corporation of the City of North Bay.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Section 16 of By-law No. 1896 aforesaid is hereby further amended by adding thereto the following:

Fraser St.	East	from a point 100 feet south of First Ave. to First Ave.	Anytime Monday to Saturday both inclusive

Peninsula Road	Highway No. 63 to the easterly limit of Peninsula Road

Murray Street	east	Jane Street to Copeland Street
Jane Street	south	Murray Street to Harvey Street
