BY-LAW NO. 146-81

BEING A BY-LAW TO ASSIGN CIVIC ADDRESS NUMBERS
PURSUANT TO SECTION 210 (106) OF THE MUNICIPAL
ACT, R.S.O. 1980, CH. 302.

WHEREAS By-law Nos. 142-79 and 47-80 of the City of North Bay
renamed certain duplicated and similar-sounding streets;

AND WHEREAS upon second reading of this By-law notice of same
will be circulated by letter to the affected property owners
and tenants of the premises indicated on Schedule "A" to this
By-law;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. The Municipal address numbers for the streets set out
on the third column of Schedule "A" attached hereto
shall apply as of the first (1st) day of January 1982.
2. The existing Municipal address numbers of buildings
and lots on the streets set out on the second column
of Schedule "A" attached hereto shall not apply as
of the first (1st) day of January 1982.
3. A certified copy of this By-law shall be registered
in the Land Registry Office for the District of
Nipissing and a copy of this By-law shall be sent
by the City Clerk to the persons shown to be the owners
and tenants of the premises set out on Schedule "A"
attached hereto upon second reading of this by-law.
4. This By-law comes into force and effect upon being
finally enacted and passed.
