

BY-LAW NUMBER 583.

BEING a By-law to provide for the payment of services rendered by the Municipality under By-law No. 531.

BE IT ENACTED AND IT IS THEREFORE HEREBY ENACTED by the Municipal Council of the Town of North Bay, as follows:-

THAT the Schedule of rates and charges for services rendered in collection, removal and disposal of ashes, food-garbage and other refuse under By-law No. 531, shall be as follows:-

- 1. Blocks ~~not~~ occupied by tenants \$1.25 per mth. removal 3 times per week.  
for house-keeping purposes
- 2. " --occupied for house-keeping purposes by, up to and not more than 4 tenants. 1.25 " " " " " & .50¢ extra per tenant.
- 3. " --occupied for house-keeping purposes by more than 4 tenants. .50 " " " " " & .35¢ extra per tenant.
- 4. Boarding Houses 2.50 per mth. removal 3 times per week.
- 5. Butcher Shops 2.50 " " " 3 " "
- 6. C.P.R. Dining Cars 6.00 " " " 3 " "
- 7. Drug Stores 1.25 " " " 1 " "
- 8. Dry Goods Stores 1.25 " " " 1 " "
- 9. Fruit & Candy Stores 3.50 " " " 3 " "
- 10. Furniture Stores 1.25 " " " 1 " "
- 11. Gents' Furnishings 1.25 " " " 1 " "
- 12. Grocers (Wholesale) 3.50 " " " 3 " "
- 13. Grocery Stores 3.00 " " " 3 " "
- 14. Hotels 6.00 " " " 3 " "
- 15. Hospital 3.00 " " " 2 " "
- 16. Jewellery Stores 1.25 " " " 1 " "
- 17. Private Houses .75 " " " 2 " "
- 18. Restaurants 3.75 " " " 3 " "

- 21. Manure 1.50 Per Load
- 22. Ashes 1.50 " "

This By-law shall take effect immediately after the passing thereof.

That all former Schedules be and the same are hereby repealed
