

BY-LAW 1805

BEING A BY-LAW OF THE CORPORATION OF THE CITY OF NORTH BAY FOR CLOSING OF PARTS OF CERTAIN LANES AS LAID DOWN AND SHOWN ON A PLAN OF SUBDIVISION REGISTERED IN THE REGISTRY OFFICE FOR THE REGISTRY DIVISION OF THE DISTRICT OF NIPISSING AS PLAN NO. 88

WHEREAS the Municipal Council of the City of North Bay deem it advisable to close certain lanes within the limits of the said Corporation of the City of North Bay, and to sell and convey the said lanes to the adjoining land owners.

AND WHEREAS notice of the intention of the Municipal Corporation of the City of North Bay to close these certain lanes has been published once a week for four consecutive weeks in the local newspaper.

AND WHEREAS the said Council has undertaken to hear in person or by their counsel, solicitor or agent, any person who claims that his or her lands will be prejudicially affected by this By-Law and who applies to be heard.

THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:



All and Singular that certain parcel or tract of land situate, lying and being in the City of North Bay in the District of Nipissing, and being composed of parts of certain lanes as laid down and shown on a plan of subdivision registered in the Registry Office for the Registry Division of the District of Nipissing as Plan No. 88, and which parcel or tract of land may be more particularly described as follows:

COMMENCING at the northwest angle of Lot 42, according to Plan No. 88; THENCE easterly along the rear limits of Lots 42, 41, 40, 39 and 38 according to the said plan, to the northeast angle of Lot 38 aforesaid; THENCE continuing easterly along the easterly production of the last described limit, 10 feet to a point in the rear limits of Lot 34, according to Plan No. 88; THENCE northerly along the rear limits of Lots 34, 33, 32 and 31, to the northwest angle of Lot 31 aforesaid; THENCE westerly in a straight line

to the northeast angle of Lot 52, according to Plan No. 88; THENCE southerly along the eastern limit of said Lot 52, to the southeast angle thereof; THENCE westerly along the rear limits of Lots 52, 51, 50, 49, 48, 47 and 46, to the intersection with the northeastern boundary of Jane Street; THENCE southeasterly in a straight line, to the point of commencement
BE AND ARE HEREBY CLOSED AND STOPPED UP.
