BY-LAW NO. 2002-19

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 131-93  
SCHEDULE 2 (NO PARKING AREAS AT ANY TIME)  
SCHEDULE 9 (DESIGNATED THROUGH HIGHWAYS)  
SCHEDULE 10 (**STOPSIGNS**)

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1990, Chapter H-S, as amended, authorizes the Council to pass by-laws regulating traffic on highways;

AND WHEREAS it is deemed expedient to regulate or prohibit certain traffic and to regulate or prohibit certain parking within the limits of the City of North Bay;

AND WHEREAS the Council of the City of North Bay passed Resolutions 2002-124, 2002-126, 2002-127, 2002-128, 2002-129 and 2002-130 at its Regular Meeting held March 11, 2002, approving the following amendments to Traffic By-Law No. 131-93;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 2 to Traffic By-Law No. 131-93 is hereby amended by adding the following:


4. That Schedule 10 to Traffic By-law No. 131-93 is hereby amended by adding the following:
