BY-LAW NO. 1153

BEING A BY-LAW to grant to John Hay McDonald, Alonzo Thomas Smith, Edward J. Roche, William R. Rankin, Robert L. McIntosh, Duncan A: Campbell and Joseph E. Cholette (who propose to form The North Bay Rink and Auditorium Company, Limited) a fixed assessment in the City of North Bay.

WHEREAS the said John Hay McDonald, Alonzo Thomas Smith, Edward J. Roche, William R. Rankin, Robert L. McIntosh, Duncan A. Campbell and Joseph E. Cholette (who propose to form The North Bay Rink and Auditorium Company, Limited) to erect and maintain in North Bay a rink and auditorium for the general use of the citizens of this City and on account of the lack of recreation facilities for the citizens of North Bay and to help to make North Bay one of the leading centres for athletics and winter sport.

AND WHEREAS it is deemed advisable by the Corporation of the City of North Bay that a fixed assessment be granted to the said John Hay McDonald, Alonzo Thomas Smith, Edward J. Roche, William R. Rankin, Robert L. McIntosh, Duncan A. Campbell and Joseph E. Cholette (who propose to form The North Bay Rink and Auditorium Company, Limited) providing the assent of the electors of the City of North Bay is first obtained thereto.

THEREFORE BE IT ENACTED AND IT IS HEREBY ENACTED BY the Municipal Corporation of the City of North Bay, providing the assent of the electors is first obtained.

1. THAT John Hay McDonald, Alonzo Thomas Smith, Edward J. Roche, William R. Rankin, Robert L. McIntosh, Dungan A. Campbell and Joseph E. Cholette (Who propose to form the North Bay Rink and Auditorium Company, Limited) be granted a fixes assessment on lots 85 and 86 King Street and the northerly eighteen (18) feet off lots 87 King Street and lots 127 and 128 Victoria Street and adjacent to lots 85 and 86 King Street and lots 127 and 128 Victoria Street and adjacent to lots 85 and 86 King Street and lots 127 and 128 Victoria Street at the following rates:-

\$1,000.00 for five years.
5,000.00 for the next five years
7,500.00 for the next five years
10,000.00 for the next five years
Commencing January the first, 1934.

- 2. That this By-Law and nothing herein contained shall apply to or affect taxation for school purposes or for local improvement purposes.
- 3. That this By-Law shall take effect from and after the first day of January, 1934, subject to its being assented to by the electors.
- 4. That the said lots and portion of lots be sold by the City of North Bay to the said John Hay McDonald, Alonzo Thomas Smith, Edward J. Roche, William R. Rankin, Robert L. McIntosh, Duncan A. Campbell and Joseph E. Cholette (who propose to form The North Bay Rink and Auditorium Company, Limted) at a price of One Dollar (\$1.00).
- 5. In the event of the citizens named or others not forming a Company known as The North Bay Rink and Auditorium Company, Limited, and going ahead to construct a rink along plans contemplated then no Conveyance will be made to an individual, individuals or Company and in the event of any transfer the individual, individuals or Company must agree to re-convey by proper contract if construction is not completed within one year of the date of final passage of this By-Law.
