

## THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 1-69

BEING A BY-LAW REPEALING BY-LAW NO. 2399  
OF THE CORPORATION OF THE CITY OF NORTH  
BAY;

AND BEING A BY-LAW ENACTING A NEW PARAGRAPH  
13 OF BY-LAW NO. 2100 OF THE CORPORATION OF  
THE CITY OF NORTH BAY.

THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY  
ENACTS AS FOLLOWS:

1. THAT By-law No. 2399 of The Corporation of the City of North Bay be and it is hereby repealed.
2. THAT a new Paragraph 13 of By-law No. 2100 of The Corporation of the City of North Bay be enacted as follows:

13. TRAVELLING EXPENSES PAYABLE TO MEMBERS OF CITY COUNCIL  
AND CITY EMPLOYEES

- (1) For the purposes of this Paragraph "travelling expenses" shall include such of the following as are applicable:

living allowance;  
meal allowance;  
transportation cost or allowance;  
registration fees for conventions or meetings.

- (2) The following applicable travelling expenses shall be payable to Members of City Council and City Employees when duly authorized to attend out of the City on City business, including conventions or meetings:

(a) When it is necessary to be away from the City overnight, a per diem living allowance of.....\$30.00

(b) When it is not necessary to be away from the City overnight, a per diem meal allowance of.....\$12.00

(c) For the wife of a delegate to the Annual Convention of the Canadian Federation of Mayors and Municipalities, a per diem living allowance of.....\$17.00

- (d) For transportation:

(i) By public conveyance - first class fare - actual expenditure only. Vouchers shall be submitted to the City Treasurer for all transportation costs by public conveyance.

(ii) By own vehicle - 12¢ per mile -  
The Council Member or City Employee shall submit to the City Treasurer a certificate setting forth:

- (a) that he travelled in his own vehicle;
- (b) the actual number of miles so travelled;
- (c) that it was necessary for him to travel the aforesaid number of miles.

No mileage allowance in excess of 400 miles one way shall be payable.

- (e) Registration fees where applicable.


- (3) Per diem living allowance or meal allowance shall not be allowed for days spent on a train.
- (4) The per diem living allowance or meal allowance for attendance at conventions or meetings shall be limited to the time during which the Council Member or City Employee is actually away from the City, and in no event shall the Council Member or City Employee be paid for a greater number of days than the number of days of the meeting or convention as publicized plus 1 day for travel each way, if necessary.
- (5) Subject to due compliance with the terms and provisions hereinbefore set forth and subject to advance payment as hereinafter set forth, the City Treasurer is hereby authorized to pay the proper and applicable travelling expenses in accordance with the foregoing provisions.
- (6) The City Treasurer is further authorized to make advance payment on account of travelling expenses in an amount, which in his opinion, will not exceed Eighty-five percent (85%) of the actual travelling expenses.

3. THIS BY-LAW shall take effect upon the final passing thereof.

READ A FIRST TIME IN OPEN COUNCIL THIS 6TH DAY OF JANUARY, 1969.

READ A SECOND TIME IN OPEN COUNCIL THIS 6TH DAY OF JANUARY, 1969.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY PASSED THIS 6TH DAY OF JANUARY, 1969.
