## THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 23-78

BEING A BY-LAW TO AMEND BY-LAW NO. 9-69 OF THE CORPORATION OF THE CITY OF NORTH BAY PURSUANT TO SECTION 35 OF THE PLANNING ACT R.S.O. 1970, CHAPTER 349, AND AMENDMENTS THERETO.

WHEREAS upon the request of the property owner concerned and with the approval of the local Planning Board, it is considered advisable to amend By-law No. 9-69 of The Corporation of the City of North Bay to provide for an alteration to the zone designation shown on Schedule "A" which forms part of said By-law No. 9-69;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1) Schedule "A" of said By-law No. 9-69 is amended by changing the zoning designation on that part of said zoning map set out in Schedule "A" attached hereto and forming part hereof, which property is more particularly described as the Easterly seven (7) feet of Lot 288 and the West Half of Lot 289, Plan 10, and shown as hatched on Schedule "B" attached hereto and forming part hereof, from a "Residential Multiple First Density (RM.1) "Zone to a "General Commercial (GC)" Zone.
- 2) All buildings or structures erected or altered in the "General Commercial (GC)" Zone hereby established shall conform to all other applicable provisions of said By-law No. 9-69, except as hereby expressly varied.
- This By-law shall take effect from the date of passing by Council and shall come into force upon the approval of the Ontario Municipal Board.






